

I believe my current experience(s) within the San Francisco Shelter system as a client would greatly enhance the efforts of the Shelter Monitoring Committee. The City of San Francisco is constantly attempting to raise the level of operation and care of the City's homeless population. As a disabled client and resident within the shelter system, I continue to gain valuable insight and understanding of the needs and challenges we face in providing on-going support services, directive and stability to our nation's homeless population.

I have been a client and participant in the homeless and disability system of the city since my return to the Bay Area in February 2010. Before this time, I have been afforded the benefit of experiencing homelessness and shelter placement in at least 25 shelters in at least 25 different states beginning with my displacement at Atlanta, Georgia in 2007. While attempting to seek out affordable safe permanent housing for myself (and possibly my young adult children), this experience has afforded me the benefit to personally witness the day-to-day operation of many of our best (and worst) shelter operations and then take away these experiences and when given the opportunity, to share with those decision making bodies objectively and insightfully how I believe services to the community can be enhanced and positively impact our nation's homeless community.

I believe my career experience initially as a lead secretary in the Bay Area nonprofit community in the late 70's to mid 80's has enhanced my level of understanding and awareness of diverse populations albeit those immigrating into our State from other countries and those less fortunate populations who continue to struggle with the barriers to acquiring permanent housing and stabilizing their life situations to keep such. This experience and my upbringing in an inter-racial family during the 50's and 60's have given me an acquired exposure and knack for having a keen awareness of diverse groups of peoples. (i.e., my parents were the first American born inter-racial couple in San Francisco County and the State of California to acquire a marriage license, 17 November and 4 December 1948).

I also have the benefit of living and experiencing the challenge of raising my three accomplished African American children in the South in the 1990's within the lowincome/affordable housing (Project Based Section 8) system at Atlanta. This served to be quite a challenge given we faced many of the ills of society—chiefly drug activity and illiteracy on a daily basis.

I have many ideas for enhancing and strengthening the positive growth toward beneficial delivery of services to our homeless population that I believe would assist in streamlining direct services, building positive staff/client relations, for example. I believe these ideas would be viable as they will not tax the City's resources nor add to the already tight resources used to operate our shelters (directly).

The Shelter Monitoring Committee currently has six expired seats, four of which are vacant, for your consideration at the today's Rules Committee meeting. All applicants who are seeking appointment should have the following information:

- Each applicant will be required to set aside 8 to 10 hours a month for the work of the Committee; s/he must attend a monthly meeting held the third Wednesday of every month and must conduct a minimum of two site visits per month. The site visits usually take place after 5:00 pm. In the past three quarters, the Committee has failed to meet minimum site inspections based on the lack of membership as well as the lack of participation by some of its current Committee Members. The Committee is in need of individuals who can commit to these time periods and if into the term they recognize they cannot meet the requirements, they should resign.
- Each applicant should be able to work in a respectful manner with shelter staff and shelter clients when conducting site inspections.
- Each applicant should note that the Committee is an information-gathering body charged with conducting inspections and submitting quarterly, or as needed, reports to the Mayor's Office and the Board of Supervisors regarding shelter conditions and policy recommendations. Additionally, the Committee takes, issues, and investigates Standard of Care complaints, which are complaints regarding health, safety, facility, staff, and disability access issues within shelters. The Committee does not have oversight over the shelters, shelter management, and staff. It is important that any perspective Member understands the Committee's legislated function and works within those parameters.
 - Language capacity is important for accessing all sites and interfacing with shelter clients.
 The Committee has not had consistent and participating Spanish-speaking Members in over two years. This has placed additional responsibilities on Committee staff. To full meet the Mission of the Committee, the Committee needs bilingual Members, specifically Spanish speakers.

Appointment of Shelter Monitoring Committee Members

The Shelter Monitoring Committee currently has six expired seats, four of which are vacant, for your consideration at the February 3, 2001 Rules Committee meeting. All applicants who are seeking appointment should have the following information:

- Each applicant will be required to set aside 8 to 10 hours a month for the work of the Committee; s/he must attend a monthly meeting held the third Wednesday of every month and must conduct a minimum of two site visits per month. The site visits usually take place after 5:00 pm. In the past three quarters, the Committee has failed to meet minimum site inspections based on the lack of membership as well as the lack of participation by some of its current Committee Members.
- Each applicant should be familiar with the legislation which created the Shelter Monitoring Committee and the latter legislation which expanded the role of the Committee. Additionally, applicants should be aware of the Mission of the Committee. The Shelter Monitoring Committee is an independent vehicle charged with documenting the conditions of shelters and resource centers to improve the health, safety, and treatment of residents, clients, staff, and the homeless community. The Committee's mission is to undertake this work recognizing individual human rights and promoting a universal standard of care for shelters and resource centers in the City and County of San Francisco.
- Each applicant should be able to work in a respectful manner with shelter staff and shelter clients when conducting site inspections.
- Each applicant should note that the Committee is an information-gathering body charged with conducting inspections and submitting quarterly, or as needed, reports to the Mayor's Office and the Board of Supervisors regarding shelter conditions and policy recommendations. Additionally, the Committee takes, issues, and investigates Standard of Care complaints, which are complaints regarding health, safety, facility, staff, and disability access issues within shelters. The Committee does not have oversight over the shelters, shelter management, and staff.

Administrative changes to seats 1 and 2 made for clarification to meet mandated positions in Ordinances 283-04 and 150-07.

The purpose of the Committee is to provide the Mayor, the Board of Supervisors, the Local Homeless Coordinating Board, the public, and any other appropriate agency with accurate, comprehensive information about the conditions in and operations of shelters, as well as City policies in place that affect operations of shelters or their impact on shelter clients. The Department of Public Health shall provide administrative support for the Committee. The Committee shall consist of 13 members, one of whom shall be a homeless person (or homeless within the 3 years prior to appointment) with a disability and one of whom shall be a homeless person (or homeless within the 3 years prior to appointment) living with their homeless child who is under the age of 18.

The 13 members of the Committee shall be appointed as follows:

Three members shall be appointed by the Mayor, including one member from the Department of Human Services:

One member from the Department of Public Health; and

One member who is homeless or formerly homeless and who has experience providing direct services to the homeless through a community setting.

Six members shall be appointed by the Board of Supervisors including: two homeless or formerly homeless (within the 3 years prior to appointment) individuals, one with a disability and one living with their homeless child under age 18; one member who has experience

providing direct services to the homeless through a community setting; one member selected from a list of candidates that are nominated by community agencies that provide behavioral health, housing placement, or other services to the homeless; and two members selected from a list of candidates that are nominated by non-profit agencies that provide advocacy or organizing services to homeless people, one of which is homeless or formerly homeless.

Four members shall be appointed by the Local Homeless Coordinating Board, including: one member selected from a list of candidates that are nominated by non-profit agencies that provide advocacy or organizing services to homeless people; two members who have experience providing direct services to the homeless through a community setting, one of which is formerly homeless; and one member shall be homeless or formerly homeless and selected from a list of candidates that are nominated by community agencies that provide behavioral health, housing placement, or other services to homeless individuals.

In making their appointments to the Committee, the appointing authorities are encouraged to select people who are bilingual.

The term of office of each Committee member shall be two years. In the event that a vacancy occurs during the term of office of any Committee member, a successor shall be appointed to complete the expired term of office. The interim appointment shall be made in the same or similar manner that governed the initial appointment of the departing member.

The Committee shall meet a minimum of once per quarter at such times and places as the Committee shall designate. The location of the meetings shall be accessible to the public and the meetings shall comply with applicable public meeting requirements under state and local law.

The Committee shall monitor the attendance of Committee members. In the event that any Committee member misses three regularly scheduled meetings in a six-month period without prior notice to the Committee, the Committee shall certify in writing that the member missed three meetings in a six-month period of time. On the date of such certification, the member shall be deemed to have resigned from the Committee. The Committee shall notify the appointing authority accordingly and request the appointment of a new member.

Sunset Date: None specified

Reports: The Committee shall prepare and submit quarterly reports that shall include but not be limited to information on the following: safety in the shelter, cleanliness in the shelter, disability access to and within the shelter, family life in the shelter, a review of policies and procedures in place at the shelter and any information received regarding the treatment and personal experiences of shelter residents. In order to enable the Committee to prepare reports required under this subsection, City departments that contract for services at a shelter that is under review must respond within 15 days to any reasonable request for information submitted by the

Committee relative to the shelter or to City policies that affect operations of shelters or their impact on shelter clients. The reports shall also include recommended action steps for the shelter and for the City department that contracts for services at the shelter. City departments and the reports referenced in this subsection shall not identify shelter residents or disclose any confidential information concerning shelter residents consistent with state and federal law. The Committee may issue emergency reports at any time it deems necessary. The reports shall be provided to: 1) the Mayor, 2) the Board of Supervisors, 3) the Local Homeless Coordinating Board, 4) the appropriate city department responsible to take action, 5) the city department that contracts for services at the shelter, 6) the shelter under review, and 7) the public. These reports shall be public documents. Any city department identified in the report as responsible to take action recommended in the report shall, within 30 days of issuance of the report, provide to the Board of Supervisors a departmental report setting forth how the department intends to respond to the Committee's recommendations.
