

1 [Contract funds to evaluate the integration of buprenorphine treatment into the SFGH AIDS
2 Program, Year 1.]

3 **Resolution authorizing the San Francisco Department of Public Health, Community**
4 **Behavioral Health Services (SFDPH, CBHS), to enter retroactively into the first year of**
5 **an agreement with the University of California San Francisco (UCSF), the primary**
6 **contractor, and expend funds in the amount of \$52,190 to provide local and multi-site**
7 **evaluation of the integration of buprenorphine treatment into the SFGH AIDS Program;**
8 **for the period of September 1, 2004 to August 31, 2005.**

10 WHEREAS, UCSF is the recipient of a grant award from the Department of Health and
11 Human Services, National Institutes of Health, for a program titled, Integrating Buprenorphine
12 into the SFGH AIDS Programs; and,

13 WHEREAS, UCSF and SFDPH,CBHS have agreed to enter into a subcontract
14 agreement to participate in this project; and,

15 WHEREAS, UCSF has agreed to reimburse SFDPH,CBHS in the amount of \$52,190
16 from this award under the terms for Year 1 of this subcontract agreement; and,

17 WHEREAS, As a condition of receiving the funds, UCSF requires SFDPH,CBHS to
18 enter into an agreement (The "Agreement"), a copy of which is on file with the Clerk of the
19 Board of Supervisors in File No. 050642, which is hereby declared to be a part of
20 this resolution as if set forth fully herein; and,

21 WHEREAS, The subcontract budget includes provision for indirect costs of \$4,190;
22 and,

23 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
24 because we did not receive the subcontract until March 22, 2005; and,

12 the agreement expires.


