3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**  
4 **and expend retroactively a grant in the amount of \$7,167 from University of California,**  
5 **San Francisco, Center for AIDS Research (CFAR); for the period of September 1, 2007**  
6 **through August 31, 2008.**

8 WHEREAS, University of California, San Francisco, Center for AIDS Research (CFAR)  
9 is the recipient of a grant award from the National Institutes of Health (NIH) to support HIV  
10 research, and CFAR will fund DPH's HIV Research Section as a participant in this project;  
11 and,

12 WHEREAS, CFAR has agreed to fund DPH in the amount of \$7,167 to partially cover  
13 the salary and fringe benefits of the Chief Medical Director of DPH's HIV Research Section for  
14 the period of September 1, 2007 through August 31, 2008; and,

15 WHEREAS, These funds will allow DPH's Chief Medical Director to serve on the  
16 Internal Advisory Board and be responsible for representing HIV investigators assisting in  
17 setting priorities and increasing the accessibility of CFAR to investigators at DPH; and,

18 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH  
19 for one existing position, Chief Medical Director (Job Class #2237) at .30 FTE, for the period  
20 of September 1, 2007 through August 31, 2008; and,

21 WHEREAS, A request for retroactive approval is being sought because the letter of  
22 intent to fund was not sent by CFAR to DPH until January 18, 2008; and,

23 WHEREAS, The budget includes a provision for indirect costs of \$1,118; now  
24 therefore, be it




