3 **Resolution determining that the transfer of a Type 20 off-sale beer and wine**
4 **license from 1469 Hyde Street to 3950 24th Street (District 8) to Joseph N. Rogoff**
5 **for Whole Foods Market California, Inc. dba Whole Foods Market, will serve the**
6 **public convenience or necessity of the people of the City and County of San**
7 **Francisco, in accordance with section 23958.4 of the California Business and**
8 **Professions Code, with conditions.**

10 WHEREAS, Joseph N. Rogoff is seeking transfer of a Type 20 off-sale beer and
11 wine license for Whole Foods Market California, Inc. dba Whole Foods Market, located
12 at 3950 24th Street (District 8); and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a
20 Type 20 off sale beer and wine license from 1469 Hyde Street to 3950 24th Street
21 (District 8) for Joseph N. Rogoff for Whole Foods Market California, Inc. dba Whole
22 Foods Market, will serve the public convenience or necessity of the people of the City
23 and County of San Francisco.

24 Conditions: (1) The sale and service of alcoholic beverages shall be permitted
25 only between the hours of 8:00 a.m. and 10:00 p.m. each day of the week; (2) The

1 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the
2 premises over which they have control; and (3) The exterior of the premises shall be
3 equipped with lighting of sufficient power to illuminate and make easily discernible the
4 appearance and conduct of all persons on or about the premises. Additionally, the
5 position of such lighting shall not disturb the normal privacy and use of any neighboring
6 residences.


