Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
des to amend only those words, phrases, paragraphs, subsections, sections, articles,  
bers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
e that are explicitly shown in this ordinance as additions, deletions, Board amendment  
ions, and Board amendment deletions in accordance with the "Note" that appears under  
fficial title of the ordinance.
