WHEREAS, the City and County of San Francisco maintains emergency operations plans to coordinate the actions of departments and agencies in times of crisis; and,

WHEREAS, The 2002 Supplemental Appropriations Act for Further Recovery From and Response to Terrorist Attacks on the United States (Public Law 107-206) authorizes federal funding to State and local governments for the updating of emergency operations plans; and,

WHEREAS, The California Governor's Office of Emergency Services has been delegated responsibility for the administration of these funds within California and grant funds are available from the Governor's Office of Emergency Services for emergency operations planning; and,

WHEREAS, The grant budget includes provision for indirect costs of \$8,972; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the Director of the Mayor's Office of Emergency Services to accept and expend an emergency operations planning grant of up to \$179,451 from the California Governor's Office of Emergency Services to fund updating emergency operations plans for the City and County of San Francisco; and be it

FURTHER RESOLVED, That the Director of the Mayor's Office of Emergency Services is hereby authorized and empowered to execute, deliver, and perform, in the name of the City and County of San Francisco, all applications, contracts, agreements, amendments and payment requests necessary for the purpose of securing such emergency operations planning grant funds and to implement and carry out the purposes specified in the applicable grant application.
