3 **Resolution authorizing the San Francisco Department of Public Health, Community**
4 **Behavioral Health Services (DPH-CBHS) to enter into a Combined Net Negotiated**
5 **Amount and Drug Medi-Cal Agreement with the State of California Department of**
6 **Alcohol and Drug Programs (DADP) for the term of July 1, 2007 through June 30, 2010**
7 **in the amount of \$55,825,476 and for the term of July 1, 2007 through June 30, 2008 in**
8 **the amount of \$18,608,492 as a condition of receiving state funds and Drug Medi-Cal**
9 **reimbursement for substance abuse treatment and prevention; holding DADP harmless**
10 **from any and all claims resulting from the agreement; authorizing and designating the**
11 **Director of CBHS to sign said Agreement and to approve amendments for less than ten**
12 **percent (10%) of the contracted amount.**

14 WHEREAS, Approval of the Combined Negotiated Net Amount and the Drug Medi-Cal
15 Agreement between DADP and SFDPH-DBHS would (1) enable the City to accept the State
16 DADP's FY 2007-08 funding allocation, or NNA, for the provision of substance abuse services
17 in San Francisco, and (2) authorize the State DADP to encumber Drug Medi-Cal funds for the
18 purpose of reimbursing the City for Drug Medi-Cal services provided by CBHS's service
19 providers in FY 2007-08, for a combined total amount of \$18,608,492; and,

20 WHEREAS, The Agreement includes a hold harmless clause which provides that the
21 City will hold the State harmless from (1) any claims and losses resulting to contractors,
22 subcontractors, individuals, firms and corporations furnishing or supplying work services,
23 materials, or supplies in connection to the performance of this contract and (2) any claims and
24 losses resulting to any person, firm, or corporation who may be injured or damaged in
25 connection to the City's performance of this contract; and

1 WHEREAS, The Director of CBHS is designated to sign the Combined Net Amount
2 and Drug Medi-Cal Agreement and approve future amendments for less than ten percent
3 (10%) of the contracted amount; now, therefore, be it


4 RESOLVED, That DPH-CBHS is hereby authorized to enter into a Combined
5 Negotiated Net Agreement and Drug Medi-Cal Agreement with DADP for the term of July 1,
6 2007 through June 30, 2010 in the amount of \$55,825,476 and for the term of July 1, 2007
7 through June 30, 2008 in the amount of \$18,608,492 as a condition of receiving State funds
8 and Drug Medi-Cal reimbursement for substance abuse treatment and prevention; and, be it

9 FURTHER RESOLVED, That said Agreement shall include an indemnification of the
10 State of California as set forth in File No. 070723; and, be it

11 FURTHER RESOLVED, That the Director of CBHS is hereby authorized and
12 designated by the Board of Supervisors to sign said Agreement and to approve Agreement
13 amendments for less than ten (10%) of the contracted amount.


