1 [Suspend 30 Day Rule - Interim Zoning Controls, Conversion of Residential Units]
2 SUSPENDING RULE 5.40 OF THE RULES OF ORDER OF THE BOARD OF
3 SUPERVISORS TO ALLOW THE BOARD OF SUPERVISORS TO CONSIDER, WITHOUT
4 WAITING 30 DAYS AFTER ITS INTRODUCTION, CONVERSION OF RESIDENTIAL
5 RENTAL USES INTERIM ZONING CONTROLS.

7 WHEREAS, Rule 5.40 of the Rules of Order of the Board of Supervisors requires that
8 when a measure is introduced that would create or revise major City policy, the measure shall
9 not be considered until at least 30 days after the day of the measure's introduction;

10 WHEREAS, Rule 4.38 of the Rules of order of the Board allows Rule 5.40 to be
11 suspended by the affirmative vote of eight members of the Board, unless there be less than
12 eight members present, in which case the unanimous consent of the members present, but
13 not less than six members, shall be required; and

14 WHEREAS, The members of the Board of Supervisors wish to suspend the operation
15 of Rule 5.40 with regard to the consideration of File 990093, Conversion Of Residential
16 Rental Uses Interim Zoning Controls; now, therefore, be it

17 MOVED, That the Board of Supervisors of the City and County of San Francisco, as
18 allowed by Rule 4.38 of its Rules of Order, hereby suspends the operation of Rule 5.40 of its
19 Rules of orders from operating with regard to the Board's consideration of a proposed
20 resolution to establish interim zoning controls on the conversion of residential units.


