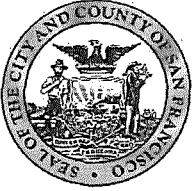



10 WHEREAS, Nunovi, LLC. is seeking the issuance of a Type-42 on-sale beer and  
11 wine public premises liquor license to do business as Ora, located at 1519 Polk Street  
12 (District 3); and

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed two protests and one letter of  
16 support with the Department of Alcoholic Beverage Control under California Business  
17 and Professions Code, Section 24013, and recommends that the Department of  
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the  
20 following: 1) The sale of alcoholic beverages for consumption off the premises is  
21 prohibited; 2) Petitioner(s) shall actively monitor the area under their control in an effort  
22 to prevent the loitering of persons on any property adjacent to the licensed premises as  
23 depicted on ABC-253; and 3) No noise shall be audible at any nearby residence; now,  
24 therefore, be it

1           RESOLVED, That in accordance with California Business and Professions Code,  
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
3 hereby determines that the issuance of a Type-42 on-sale beer and wine public  
4 premises liquor license to Nunovi, LLC, doing business as Ora, located at 1519 Polk  
5 Street, will serve the public convenience or necessity of the City and County of San  
6 Francisco; and, be it

7           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
8 San Francisco hereby endorses and adopts the recommendations of the Police  
9 Department listed above and recommends that the Department of Alcoholic Beverage  
10 Control issue the license with those conditions.
