4 **Kevin White against the City and County of San Francisco for \$195,000; the lawsuit was**
5 **filed on November 9, 2023, in San Francisco Superior Court, Case No. CGC-23-610311;**
6 **entitled Annamarie Faro, et al. v. City and County of San Francisco, et al.; the lawsuit**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Annamarie Faro, et al. v. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-610311 by
13 the payment of \$195,000. The lawsuit involves alleged property damage arising from
14 flooding.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 November 9, 2023, and the following parties were named in the lawsuit: Annamarie Faro and
17 Howard Kevin White, Plaintiffs; City and County of San Francisco, Defendant.
