2 AUTHORIZING THE ISSUANCE OF HONORARY CERTIFICATES TO DOMESTIC
3 PARTNERS PARTICIPATING IN THE DOMESTIC PARTNERSHIP CEREMONY TO BE
4 HELD IN CITY HALL ON MARCH 23, 2000.

5 WHEREAS, The City and County of San Francisco has officially recognized and
6 sanctioned domestic partnerships as a means for two persons to declare their love and
7 commitment to one another since at least 1991; and,

8 WHEREAS, The City offers residents and persons who work in the City the opportunity
9 to register as domestic partners with the San Francisco County Clerk and to have their
10 partnership celebrated in an official commitment ceremony memorialized by issuance of a
11 Domestic Partnership Ceremony Certificate; and,

12 WHEREAS, The City is organizing a domestic partnership commitment ceremony in
13 San Francisco's City Hall on March 23, 2000 to celebrate domestic partnerships of persons
14 who live outside of San Francisco, and,

15 WHEREAS, Domestic partners who do not reside or work in the City may not register
16 with the County Clerk's Office for an official commitment ceremony memorialized by issuance
17 of a Domestic Partnership Ceremony Certificate, therefore, be it

18 RESOLVED, The County Clerk is hereby authorized to issue honorary certificates of
19 commitment to each of the domestic partner couples that participates in the domestic
20 partnership commitment ceremony celebrated in San Francisco's City Hall on
21 March 23, 2000, and, be it

22 FURTHER RESOLVED, The County Clerk is hereby authorized to accept donations
23 made to the City and County of San Francisco by persons participating in the domestic
24 partnership ceremony on March 23, 2000.




