13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Chapter 2A, Article V, of the Administrative Code is hereby amended by
 15 deleting Section 2A.91 and revising 2A.93, to read as follows:

16 **~~SEC. 2A.91. FIRE DEPARTMENT PHYSICIAN.~~**

17 ~~*The Fire Commission shall appoint a Department Physician who shall hold office at its*~~
 18 ~~*pleasure.*~~

19 **SEC. 2A.93. FIRE; DEPUTY CHIEFS; OTHER EXECUTIVES.**

20 The Chief of the Fire Department shall have the power to appoint and to remove, at the
 21 Chief's pleasure, two Deputy Chiefs from among the members of the Department having the
 22 rank of Assistant Chief of Department or Battalion Chief; one Deputy Chief from among the
 23 members of the Department having the from among the Emergency Medical Services or Community
 24 Paramedicine members of the Department with a rank of Rescue Captain, Section Chief, Battalion
 25 Chief, or above, and who has served as a paramedic within the Department; and a Secretary to the
 Chief of the Department.

Section 2. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the “Note” that appears under the official title of the ordinance.

Section 3. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor’s veto of the ordinance.
