3 **Resolution extending by 90 days the prescribed time within which the Planning**  
4 **Commission may render its decision on a proposed Ordinance that would amend the**  
5 **Planning Code by adding Section 226.5 to impose a distance requirement of 500 feet or**  
6 **more between new off-sale liquor stress and existing liquor stores, schools public**  
7 **libraries, and recreation centers and establishing conditions for operation of liquor**  
8 **stores.**

10 WHEREAS, On February 26, 2008, Supervisor Sandoval introduced legislation to  
11 initiate the process amending the San Francisco Planning Code by adding Section 226.5 to  
12 impose a distance requirement of 500 feet or more between new off-sale liquor stores and  
13 existing liquor stores, schools, public libraries and recreation centers and establishing  
14 conditions for operation of liquor stores, and making findings, including environmental findings  
15 and findings of consistency with the priority policies of Planning Code Section 101.1 and the  
16 General Plan. A copy of said legislation is on file with the Clerk of the Board of Supervisors  
17 in File No. 080062 and is incorporated herein by reference; and,

18 WHEREAS, On or about February 29, 2007, the Clerk of the Board of Supervisors  
19 referred the proposed ordinance to the Planning Commission, which currently is reviewing the  
20 proposed ordinance; and,

21 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by  
22 resolution, extend the prescribed time within which the Planning Commission is to render its  
23 decision on proposed amendments to the Planning Code that the Board of Supervisors  
24 initiates; and,
