3 **Ordinance authorizing settlement of the lawsuit filed by Barnard Jones and Patricia**
4 **Farrell against the City and County of San Francisco for \$475,000; the lawsuit was filed**
5 **on June 28, 2023, in San Francisco Superior Court, Case No. CGC-23-607339; entitled**
6 **Barnard Jones, et al. v. City and County of San Francisco, et al.; the lawsuit involves**
7 **alleged personal injury on a City street.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Barnard Jones, et al. v. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-607339 by
13 the payment of \$475,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on June
15 28, 2023, and the following parties were named in the lawsuit: plaintiffs Barnard Jones and
16 Patricia Farrell; defendant City and County of San Francisco.
