10 WHEREAS, John Madden in 1991 was appointed Chief Assistant Controller under the tenure of then Controller  
11 Ed Harrington and it is at this capacity from which he will retire; and,

12 WHEREAS, John Madden taught at the Community College District for six years; and,

13 WHEREAS, John Madden is a native San Franciscan; and,

14 WHEREAS, Attended Mission High School, The University of San Francisco, and San Francisco State where he  
15 received his Masters Degree; and,

16 WHEREAS, John Madden is an avid 49er fan and season ticket holder as far back as the Kezar Park days where it  
17 is said that John could have been found selling hot dogs during a 49er game; and,

18 WHEREAS, John Madden was married to Nan in St. Cecilians' Church in the Sunset District ; and,

19 WHEREAS, John Madden is known for his dry sense of humor and ability to work well with Department Heads  
20 and fellow city employees; now, therefore, be it
