## RESOLUTION NO.

1	[Approving emergency work for the San Francisco Municipal Transportation Agency to
2	replace curved tracks on the Muni Metro Muni Metro L-line at 15 <sup>th</sup> Avenue and Taraval
3	Street, 15 <sup>th</sup> Avenue and Ulloa Street, and the Zoo Loop.]
4	
5	Resolution approving emergency work for the San Francisco Municipal Transportation
6	Agency to replace curved tracks on the Muni Metro Muni Metro L-Line at 15 <sup>th</sup> Avenue
7	and Taraval Street, 15 <sup>th</sup> Avenue and Ulloa Street, and the Zoo Loop.
8	
9	WHEREAS, On February 28 <sup>th</sup> , 2002, a Muni Metro streetcar derailed at the intersection
10	of 15 <sup>th</sup> Avenue and Taraval Street, resulting in major damage to the streetcar and to the
11	vehicles parked on the street; and,
12	WHEREAS, The Zoo Loop is comprised of the Muni Metro streetcar tracks on (1)
13	46 <sup>th</sup> Avenue between Taraval and Wawona Streets, (2) 47 <sup>th</sup> Avenue between Vicente and
14	Wawona, and (3) Vicente and Wawona Streets between 46 <sup>th</sup> and 47 <sup>th</sup> Avenues; and,
15	WHEREAS, The curved tracks on the Muni Metro L-Line at 15 <sup>th</sup> and Taraval Street,
16	15 <sup>th</sup> Avenue and Ulloa Street and the Zoo Loop are extremely worn and have deteriorated in
17	the last few months; and,
18	WHEREAS, Emergency work is required to prevent the loss of essential public services
19	and to safeguard the public health and welfare by avoiding any future accidents; and,
20	WHEREAS, The Municipal Transportation Agency ("Agency") will design, procure, and
21	install tracks at these locations; and,
22	WHEREAS, The project is funded by 80% Federal grants and 20% local funds, and no
23	supplemental appropriation is required from the General Fund; and,
24	WHEREAS, H. Welton Flynn, Chair of the Municipal Transportation Agency Board of
25	Directors, approved the emergency work on April 18, 2002, as required under Section 6.60(D)

1	of the San Francisco Administrative Code; a copy of Said approval letter is contained in Board
2	of Supervisors File No, which is hereby declared to be a part of this
3	resolution as if set forth fully herein; and,
4	WHEREAS, The Agency will solicit a minimum of three informal bids for a contract to
5	perform the emergency work; and,
6	WHEREAS, The Agency shall make every effort to comply with the requirements of
7	Chapters 12A, 12B, and 12C of the Administrative Code, as well as applicable federal
8	contracting requirements; now, therefore, be it
9	RESOLVED, That the San Francisco Board of Supervisors approved the emergency
10	work to be performed by and through the Municipal Transportation Agency to replace curved
11	tracks on the Muni Metro L-Line at 15 <sup>th</sup> Avenue and Taraval Street, 15 <sup>th</sup> Avenue and Ulloa
12	Street and the Zoo Loop, authorizes the Agency to take all actions necessary to complete this
13	work in the most expeditious manner, and ratifies all actions taken by the Agency to date
14	regarding this emergency work.
