3 **Resolution approving the City and County of San Francisco 2011 Public Safety**
4 **Realignment Plan.**

6 WHEREAS, The Public Safety Realignment Act, Assembly Bill 109 ("AB 109") was
7 signed into law by Governor Edmund G. Brown on April 4, 2011 and takes effect on
8 October 1, 2011; and

9 WHEREAS, Assembly Bill 117 amending certain provision of AB 109 was signed into
10 law by Governor Edmund G. Brown on June 30, 2011 and also takes effect on
11 October 1, 2011; and

12 WHEREAS, California Penal Code section 1230.1 as added by AB 109 and as
13 amended by AB 117 requires the City's Community Corrections Partnership to recommend a
14 local plan for the implementation of 2011 public safety realignment; and

15 WHEREAS, Section 1230.1(b) further requires that an executive committee of the
16 Community Corrections Partnership be formed to approve presentation of the plan to the
17 Board of Supervisors, and that the committee consist of the chief probation officer, the chief of
18 police, the sheriff, the district attorney, the public defender, the presiding judge of the superior
19 court or the court's designee, and the head of either the agency in charge of social service,
20 mental health, or alcohol and substance abuse programs, as designated by the Board of
21 Supervisors; and

22 WHEREAS, Pursuant to 1230.1(c) the plan shall be deemed accepted by the County
23 Board of Supervisors unless rejected by a vote of 4/5ths, in which case the plan goes back to
24 the Community Corrections Partnership for further consideration; and

1 WHEREAS, a copy of the "City & County of San Francisco Public Safety Realignment
2 & Post Release Community Supervision 2011 Implementation Plan" is on file with the Clerk of
3 the Board of Supervisors in File No. 110920, which is hereby declared to be a part of this
4 motion as if set forth fully herein; and,

5 RESOLVED, The City and County of San Francisco 2011 Public Safety Realignment
6 Implementation Plan, including the proposed budget, is hereby adopted by the Board of
7 Supervisors.
