9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. On June 1, 1999, Mayor Brown and the Mayor's Office of Criminal Justice
11 established the Shayne Worcester Reward Fund to be paid to any individual supplying
12 information that led to the arrest and conviction of the person or persons responsible for the
13 death of Shayne Worcester on May 26, 1999. The Reward Fund provided that moneys be
14 paid only if a suspect is convicted or pleads guilty. A Jane Doe came forward and supplied
15 information leading to the arrest and conviction of the four persons responsible for the death
16 of Shayne Worcester. The final suspected has been tried and the jury found the defendant
17 guilty of first degree murder.

18 Section 2. The Controller of the City and County of San Francisco is hereby authorized
19 to draft a warrant upon the Treasury of the City and County of San Francisco in the amount of
20 Twelve Thousand Five Hundred Dollars (\$12, 500) payable to Jane Doe for supplying
21 information leading to the arrest and conviction of the perpetrators who murdered Shayne
22 Worcester.




