3 Resolution authorizing the Department of the Environment to accept and expend a
4 grant in the amount of \$90,000 from the California Department of Toxics Substances for
5 the purpose of collaborating with California Green Business Network members to
6 develop a regional, web-based database that will help Green Business Programs

9 WHEREAS, The California Department of Toxics Substances has awarded a \$90,000
10 grant to the Department of the Environment for the City and County of San Francisco (SF
11 Environment) for the purpose of collaborating with California Green Business Network
12 members to develop a regional, web-based database that will help Green Business Programs
13 manage and track data; and,

14 WHEREAS, The last five years have seen tremendous growth of and enthusiasm for
15 Green Business Programs; and,

16 WHEREAS, as Green Business Programs grow in California, there is a very real need
17 for robust tools for managing data, tracking business information and measuring Green
18 Business Program effectiveness; and,

19 WHEREAS, Green Business Program staff recognize that measuring environmental
20 savings (KWH energy saved, gal water saved, pounds of waste diverted, pounds of toxics
21 reduced and greenhouse gas emissions saved) would acknowledge Green Business
22 Programs as one of the State's most valuable environmental efforts; and,

23 WHEREAS, This project will serve as an important model for the other regions and
24 States, as it will showcase financial and environmental benefits achieved by local businesses

1 through green business practices and motivate other States in the nation to adopt similar
2 programs; and,


3 WHEREAS, This project highlights San Francisco's leadership role on environmental

6 allowed by the funding source, and;


7 WHEREAS, This grant does not require an ASO amendment; now, therefore, be it


