Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Brian Hill v. San Francisco Water Power Sewer, and Does 1 to 10, San Francisco Superior Court, Case No. CGC 14-538953, by the payment of \$30,400.
