3 **Resolution in Opposition to Senate Bill 670 (Correa) Barring Development fees**
4 **imposed for the acquisition of Open Space, Parks, Public Recreational Facilities and**

7 WHEREAS, The City and County of San Francisco is currently engaged in a vigorous
8 spate of new home, commercial and other land dependent development; and,

9 WHEREAS, The City and County of San Francisco has a diminishing amount of land
10 available for public purposes; and,

11 WHEREAS, The Planning Department of City and County of San Francisco has and
12 continues to develop protocols and programs for citizen input into neighborhood planning
13 processes which demands continuous funding; and,

14 WHEREAS, The City and County of San Francisco is constantly asked fund acquisition
15 of open space for parks, recreational facilities and other amenities considered essential to
16 enhancing the urban quality of life collectively know as community benefits; and,

17 WHEREAS, Recent development projects, as a condition of their approval or for
18 approval of variances to height and density restrictions, have been the source of and
19 amenable to development fees to underwrite community benefits at substantially reduced or
20 even no cost to the taxpayer; and,

21 WHEREAS, The City and County of San Francisco finds that it is desirable to continue
22 to be able to fund community benefits through such development fees; and,

23 WHEREAS, Senate Bill 670 now pending in the California State Legislature would
24 prohibit imposition of such fees; now, therefore be it

2 hereby opposes Senate Bill 670; and, be it

7 to the appropriate legislative committees' files.
