

1 [Partial Settlement of Lawsuit - Joy Caguimbaga and Zenida C. Restauero - \$240,000]

3 **Ordinance authorizing partial settlement of the lawsuit filed by Joy Caguimbaga and**  
4 **Zenida C. Restauero against the City and County of San Francisco for \$240,000; the**  
5 **lawsuit was filed on August 20, 2015, in San Francisco Superior Court, Case**  
6 **No. CGC-15-547492; entitled David Alfaro, et al. v. City and County of San Francisco;**  
7 **the lawsuit involves inverse condemnation arising out of flooding damage during major**  
8 **rainstorms in December of 2014; this settlement relates only to the diminution of real**  
9 **property value claims of plaintiffs Joy Caguimbaga and Zenida C. Restauero, and does**  
10 **not include claims for property loss or for attorney's fees, costs and interest.**

11  
12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
14 authorizes the City Attorney to settle in part, and only as to plaintiffs Joy Caguimbaga and  
15 Zenida C. Restauero, the action entitled David Alfaro, et al. v. City and County of San  
16 Francisco, San Francisco Superior Court, Case No. CGC-15-547492 by the payment  
17 of \$240,000 to plaintiffs Joy Caguimbaga and Zenida C. Restauero. The lawsuit involves  
18 inverse condemnation arising out of flooding damage during major rainstorms in December  
19 of 2014.

20 Section 2. The above-named action was filed in San Francisco Superior Court on  
21 August 20, 2015. This is an action brought by owners or occupants of several dozen  
22 properties located in San Francisco against defendant City and County of San Francisco.

23 Section 3. This is a partial settlement of the action. It resolves the diminution of real  
24 property value claims of plaintiffs Joy Caguimbaga and Zenida C. Restauero. The parties have  
25 previously, separately settled the personal and real property damage claims of plaintiffs Joy

1 Caguimbaga and Zenida C. Restauero in this action, and will subsequently and separately  
2 address all claims for statutory attorney's fees relating to this action.
