

1 [Renew Revolving Loan Funds Agreement with State]

3 **Resolution authorizing the Office of the District Attorney to renew its current**
4 **agreement with the California Victim Compensation and Government Claims Board, an**
5 **agent of the State of California, for a revolving loan fund in the amount of \$75,000 to be**
6 **used to pay for verified funeral/burial expenses and emergency relocation for victims**
7 **of domestic violence and sexual assault.**

9 WHEREAS, The District Attorney and the City and County of San Francisco desires to
10 renew its current contract with the Victim Compensation and Government Claims Board to
11 provide a means to pay for verified funeral/burial expenses and emergency relocation for
12 victims of domestic violence and sexual assault, and be reimbursed by the State thereafter;
13 and,

14 WHEREAS, This contract would authorize the District Attorney's Victim Witness
15 Assistance Program to pay verified funeral/burial expenses and emergency relocation for
16 victims of domestic violence and sexual assault out of the revolving funeral/burial fund; and,

17 WHEREAS, The fund maintains a process by which the District Attorney may make
18 speedy payments to service providers and increase services to victims; now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of
20 the City and County of San Francisco to renew the contract with the California Victim
21 Compensation and Government Claims Board, extending it for additional year, from July 1,
22 2004 through June 30, 2005; and be it

23 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of
24 the City and County of San Francisco the necessary revolving fund agreements with the



1 Victim Compensation and Government Claims Board for purposes including any extensions,
2 augmentations or amendments thereof; and be it

3 FURTHER RESOLVED, That the District Attorney is authorized to sign and submit
4 claims to the Victim Compensation and Government Claims Board for reimbursement of funds
5 expended for verified funeral/burial expenses and emergency relocation for victims of
6 domestic violence and sexual assault; and be it

7 FURTHER RESOLVED, That the State funds received hereunder shall not be used to
8 supplant local funds that would, in the absence of the agreement, be made available to
9 support assistance to victims of crime.




