2 California Department of Public Health - Asylum Seeker Health Surveillance and Linkage to
3 Care - \$226,000]

4 **Resolution retroactively authorizing the Department of Public Health to accept and**
5 **expend a grant in the amount of \$226,000 from the Centers for Disease Control and**
6 **Prevention through the California Department of Public Health for participation in a**
7 **program, entitled “Asylum Seeker Health Surveillance and Linkage to Care,” for the**
8 **period of September 1, 2022, through June 30, 2023.**

10 WHEREAS, Centers for Disease Control and Prevention (CDC), through the California
11 Department of Public Health (CDPH) as a pass-through entity, has agreed to fund the San
12 Francisco Department of Public Health (DPH) in the amount of \$226,000 for participation in a
13 program, entitled “Asylum Seeker Health Surveillance and Linkage to Care,” for the period of
14 September 1, 2022, through June 30, 2023; and

15 WHEREAS, DPH provides case management services to asylum seekers annually to
16 ensure patient enrollment in Medi-Cal or other health insurance when eligible; and

17 WHEREAS, DPH conducts health screenings to assess healthcare needs of asylum
18 seekers, and connects them with healthcare services and immunizations for vaccine-
19 preventable diseases; and

20 WHEREAS, Health screener and assessment data will be entered into the Asylum
21 Seeker Health Surveillance database where it will be accessible for program monitoring and
22 disease surveillance reporting; and

23 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

24 WHEREAS, A request for approval is being sought because DPH received the award
25 letter on June 28, 2022, for a project start date of September 1, 2022; and

1 WHEREAS, The Department proposes to maximize use of available grant funds on
2 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

3 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
4 the grant budget; and, be it

5 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
6 expend a grant in the amount of \$226,000 from CDPH; and, be it

7 FURTHER RESOLVED, That DPH is hereby authorized to accept and expend the
8 grant funds pursuant to Administrative Code, Section 10.170-1.


