(Tenant) operates its American Express Centurion Lounge (Lounge) on the post-security mezzanine level of Terminal 3 (T3 West). The Airport has a Capital Improvement Program (Terminal 3 West Modernization Program) underway which necessitates closure of the Lounge for a period of approximately two years due to the relocation of the Lounge entrance. To preserve service for the users of the Lounge, jobs for Tenant employees, and revenue to the Airport during the closure, Staff recommends approval of Amendment No. 3 to the Lease (Amendment) which will provide for the temporary operation of the Lounge in a vacant former airline lounge in Terminal 2 at no cost to the Airport. The Amendment also commits the Airport, at its sole cost, to relocating the Lounge entrance as part of the T3 West Modernization Program and preserves the day-for-day extension of the term of Tenant's lease as a result of the closure.
