WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to approve by Resolution contracts estimated to cost the City \$10,000,000 or more; and

WHEREAS, This Agreement was competitively procured as required by Administrative Code, Chapter 21.1, through Invitation for Bids #74103, issued on March 6, 2017, in which City selected MSC Industrial Supply Company Inc. (Contractor) as the lowest qualified bidder pursuant to the Invitation for Bids; and

WHEREAS, The Purchaser entered into an as-needed term contract with Contractor, dated May 1, 2017, to purchase industrial supplies for City departments, as amended by the:

Modification No. 1, January 23, 2019, which increased contract not to exceed amount to \$5,000,000;

Modification No. 2, June 28, 2019, which increased contract not to exceed amount to \$6,500,000;

Modification No. 3, February 3, 2020, which extended contract end date to April 30, 2021, and increased contract not to exceed amount to \$8,500,000;

Modification No. 4, October 20, 2020, which extended contract end date to April 30, 2022, and increased contract not to exceed amount to \$9,500,000;

Modification No. 5, April 26, 2021, which increased contract not to exceed amount to \$9,900,000;

WHEREAS, The Office of Contract Administration proposes to enter into a sixth amendment (Modification No. 6), increasing the total not to exceed contract amount to \$14,277,623, and extending the contract duration to June 30, 2023 to meet City business needs; and

WHEREAS, The amendment referenced above is on file with the Clerk of the Board of Supervisors in File No. 211003, which is hereby declared to be part of this Resolution as if set forth fully herein; now, therefore, be it

RESOLVED, That the Board of Supervisors, under Charter, Section 9.118(b), hereby authorizes the Purchaser and Director of the Office of Contract Administration to execute Modification No. 6 to the contract to increase the contract amount by \$4,377,623 for a total contract amount of \$14,277,623, and to extend the duration by one year and two months to June 30, 2023; and, be it
