## **REVISED LEGISLATIVE DIGEST**

Amended, 11/17/2021

[Public Works Code - Waiver of Temporary Street Space Occupancy Permit Fee - Sidewalk Sales During the Holiday Season]

Ordinance waiving the fee required by Public Works Code, Section 724.1(b) for temporary street space occupancy permits on City streets on Saturday, December 4, 2021, Sunday, December 5, 2021, Saturday, December 11, 2021, and Sunday, December 12, 2021, to promote sidewalk sales of merchandise during the holiday season.

#### **Existing Law**

Section 724.1(b) of the Public Works Code requires that a fee of \$57.62 per day be charged "[f]or temporary street space occupancy for any purpose other than a building construction operation."

#### Amendments to Current Law

This uncodified ordinance would temporarily waive the fee required by Section 724.1(b) of the Public Works Code, City-wide, in connection with the sidewalk sales of merchandise during the holiday season. The fee would be waived between 7 a.m. and 9 p.m. on Saturday, December 4, 2021, Sunday, December 5, 2021, Saturday, December 11, 2021, and Sunday, December 12, 2021. If the ordinance were to become effective after December 4, 2021, the ordinance would be retroactive to that date.
