Breed's Proclamation declaring a Local Emergency issued on February 25, 2020, 17 including the guidance for gatherings issued by the San Francisco Department of Public 18 19 Health Officer, aggressive directives were issued to reduce the spread of COVID-19 and on March 17, 2020, the Board of Supervisors authorized their Board and Committee 20 21 meetings to convene remotely; and 22 WHEREAS, The Twenty-Fourth Supplement to the Mayoral Proclamation Declaring 23 the Existence of a Local Emergency, dated July 31, 2021, provisions the Board of Supervisors and its committees to hold in person meetings with remote public participation 24 25 and observation, and California Assembly Bill 361 allows for teleconferenced meetings so
