I'm a District 7 resident, I'm 74 years old, and a member of Sunnyside Neighborhood Association & San Francisco SAFE.

I'm writing to make sure you know that the bad state of our sidewalks is a huge burden on me and others like me.

A collapsed sidewalk at the end of my block is a danger to anyone walking by it. My dog & I carefully walk past it daily. Years ago (5? 6?) someone put a folding sawhorse beside the hole in the ground. A temporary, inadequate solution at best.

I recently opened Service Request Number 14632599 to address this persistent problem. The request was opened on Nov. 11 2021 & Closed Nov. 28. In spite of this, the hole in the sidewalk remains a pedestrian hazard. Please see the attached photos.

I urge you to fix our sidewalks now so that older adults and people with disabilities can travel safely and with ease.
