3 **Ordinance authorizing settlement of the lawsuit filed by Steven D. Lee against the City**  
4 **and County of San Francisco for \$600,000; the lawsuit was filed on April 29, 2020, in**  
5 **San Francisco Superior Court, Case No. CGC-20-584260; entitled Steven D. Lee v. City**  
6 **and County of San Francisco, et al.; the lawsuit involves alleged personal injury on a**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Steven D. Lee v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-584260 by the  
13 payment of \$600,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 April 29, 2020, and the following parties were named in the lawsuit: plaintiff: Steven D. Lee;  
16 defendant: City and County of San Francisco.
