3	Motion setting July 1, 2022, as the Transition Date, pursuant to Charter, Section
4	4.139(d), for purposes of establishing the Sanitation and Streets Commission; the
5	Sanitation and Streets Department will come into existence three months after the
6	Transition Date.

8	WHEREAS, On November 3, 2020, the voters approved Proposition B, which amended
9	the San Francisco Charter to create a Department of Sanitation and Streets ("Department") to
10	succeed to specific duties currently performed by the Department of Public Works, and a
11	Sanitation and Streets Commission ("Commission") to oversee the Department of Sanitation
12	and Streets; and
13	WHEREAS, Pursuant to Charter, Section 4.139(d), the Board of Supervisors must vote
14	by no later than January 1, 2022, on a written motion to establish a Transition Date, which
15	dictates various deadlines relating to the establishment of the Commission and the
16	Department; and
17	WHEREAS, Appointing officers must make appointments to the Commission no later
18	than three months before the Transition Date; and
19	WHEREAS, By no later than the Transition Date, the Board of Supervisors must enact
20	an ordinance requiring the City Administrator, the Department of Public Works, and/or any
21	other City department to provide administrative support for the Department; and
22	WHEREAS, By no later than the Transition Date, the City Administrator must submit to
23	the Board of Supervisors a proposed ordinance amending the Municipal Code to conform to
24	changes made by Proposition B; and
25	WHEREAS, The Commission will come into existence on the Transition Date; and

1	WHEREAS, The Department will come into existence three months after the Transition
2	Date; and
3	WHEREAS, Under Charter, Section 4.139(d), the Transition Date may be no earlier
4	than July 1, 2022; and
5	WHEREAS, If the Board of Supervisors fails to adopt a motion establishing a Transition
6	Date by January 1, 2022, the Clerk of the Board of Supervisors must place such a motion on
7	the agenda of a Board of Supervisors meeting at least once every three months thereafter
8	until such time as the Board of Supervisors adopts a motion establishing the Transition Date;
9	now, therefore, be it
10	MOVED, That pursuant to Charter, Section 4.139(d), the Board of Supervisors
11	establishes July 1, 2022, as the Transition Date for purposes of establishing the Commission
12	and the Department.
