Article 2 of the Park Code is hereby amended by adding Section 2.10. to 14 15 read as follows: 16 SEC. 2.10. "VETERAN" DEFINED. (a) When used in this Code, the word "Veteran" shall mean a person who is currently serving 17 18 in the active military, naval, air, or space service, or who has completed such service and was discharged or released therefrom under conditions other than dishonorable consistent with Section 19 20 101(2) of Title 38 of the United States Code, as it may be amended from time to time; and provided further, that for purposes of this Code, the term "Veteran" shall only apply to such persons 21 22 who are residents of the City and County of San Francisco. (b) The proviso in subsection (a) that excludes non-San Francisco residents from the 23 definition of "Veteran" shall expire by operation of law if and when the Controller certifies, in 24 25 writing, to the Recreation and Park Department General Manager, that the City has enacted

an ordinance appropriating monies necessary to fund discounts for one year for non-San Francisco residents who otherwise meet the definition of "Veteran." Following said certification, the City Attorney shall cause this subsection (b), and the proviso in subsection (a), to be removed from the Code.

Section 2. Article 12 of the Park Code is hereby amended by revising Sections 12.01, 12.02, 12.05, 12.06, 12.07, 12.34, 12.40, 12.41, and 12.46, to read as follows:

SEC. 12.01. CAMP MATHER CABIN AND TENT SITE USAGE FEES.

(a) The following use fees, which reflect a discount from the standard fee for nonresidential usage, shall be charged to San Francisco residents for use of cabin and tent sites at Camp Mather. The following fees do not include State occupancy tax.

The Department General Manager or his or her designee may also approve fees and charges for tennis-related services and items at the Golden Gate Park Tennis Center other than those specifically listed in this Section 12.41, based on prevailing rates for those services and items at comparable facilities in the Bay Area.

Section 3. Scope of Ordinance.

(a) In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.

(b) The various codified fees presented as existing Code text in Section <u>2</u>4 of this ordinance do not necessarily reflect the fees that are currently applicable. Pursuant to Park Code Section 12.20, the Controller adjusts those fees on an annual basis to reflect changes in

the Consumer Price Index. This ordinance is not intended to invalidate any adjustments under Section 12.20 that the Controller has previously approved.

Section 4. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 5. Funding. This ordinance grants certain discounts to Veterans, but at Park Code Section 2.01, provides that these discounts only apply to Veterans who are residents of the City and County of San Francisco. The Board of Supervisors intends that the discount program should expand to non-resident Veterans once the City has enacted an ordinance appropriating monies necessary to fund these discounts for one full year. Thereafter, it is the intent of this Board of Supervisors that such monies should also be appropriated in future fiscal years.
