3 **Ordinance authorizing settlement of the lawsuit filed by Andrea Gansheimer against**  
4 **the City and County of San Francisco for \$315,000; the lawsuit was filed on**  
5 **January 23, 2020, in San Francisco Superior Court, Case No. CGC-20-582426; entitled**  
6 **Andrea Gansheimer v. City and County of San Francisco, et al.; the lawsuit involves**  
7 **alleged personal injury from vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Andrea Gansheimer v. City and  
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-582426 by  
13 the payment of \$315,000. The lawsuit involves alleged personal injury from vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 January 23, 2020, and the following parties were named in the lawsuit: plaintiff: Andrea  
16 Gansheimer; defendant: City and County of San Francisco.
