3 **Motion scheduling the Board of Supervisors to sit as a Committee of the Whole on**
4 **January 4, 2022, at 3:00 p.m., during the regular Board of Supervisors Meeting, to hold**
5 **a public hearing on the Mayor’s December 17, 2021 Proclamation of a Local Emergency**
6 **Relating to Drug Overdoses in the Tenderloin.**

8 WHEREAS, On December 17, 2021, Mayor London N. Breed declared a local
9 emergency to exist in connection with the sudden increase of drug overdoses in the
10 Tenderloin; and

11 WHEREAS, The Mayor transmitted a copy of the Proclamation Declaring the Existence
12 of a Local Emergency (“Proclamation”) to the Board of Supervisors, and such copy is on file
13 with the Clerk of the Board of Supervisors in File No. 211320; and

14 WHEREAS, Government Code, Sections 8550 et seq., and Charter, Section 3.100,
15 provide for the concurrence by members of the Board of Supervisors in such emergency
16 declaration and in actions taken by the Mayor to meet the emergency; and

17 WHEREAS, On December 23, 2021, the Board of Supervisors convened as a
18 Committee of the Whole and concurred in the Proclamation; now, therefore, be it

19 MOVED, That the Board of Supervisors convene to sit as a Committee of the Whole on
20 January 4, 2022, at 3:00 p.m. to hold a hearing on the Mayor’s December 17, 2021,
21 Proclamation.
