Hey Jeanie,

Thank you for giving me a call back yesterday and walking me through the next steps for the project. I understand it is too late for official comments, but I wanted to get back to you sooner rather than later.

I have briefly reviewed the CEQA document, including the mitigation measures. The only few comments I had were:

CDFW would ask that you avoid any construction activities after sunset and not to start up construction activities until after sunrise. Noise and vibrations can cause impacts to nearby species.

Preconstruction surveys, specifically for nesting birds and vegetation is something I would strongly urge. Nesting bird surveys may need to be done multiple times a year if nests are found during the preconstruction survey. As mentioned in the CEQA document, consultation with CDFW may be needed. Please feel free to reach out to me if you have anything that comes up.
