In the Spring of 2020, the Board of Supervisors reviewed and approved several key documents related to the Power Station project (formerly known as "Potrero Power Station"). Legislation included the Development Agreement which provided for the formation of a Special Tax District as a key element in the project's financing plan.

Please find attached, and outlined below, the second and final legislative packet for the formation of the Power Station Special Tax District and related Tax Levying activities. The Mayor's Office intends to introduce these documents at this afternoon's Board meeting. In coordination with the Clerk's Office and the Office of President Walton, a Committee of the Whole to hear these items is proposed for Tuesday, March 8th. Staff from the Controller's Office of Public Finance and Office of Economic and Workforce Development would be more than happy to set up briefings with you and your teams or answer any questions you might have in advance of that hearing.

The first tranche of legislation comprising of a Resolution of Intention to Form Special Tax District and Resolution of Intention to Incur Bonded Indebtedness was introduced on December 14th, 2021 and will be coming to the full Board also at this afternoon's meeting with a positive recommendation from the Budget and Finance Committee's January 12th, 2022 meeting.
