\* One (1) shall be active in a community organization

> Two (2) members appointed by the Controller:

\* One (1) with expertise in auditing governmental financial statements or with expertise in public finance law

\* One (1) with expertise in construction management

> One (1) member shall be a member of the Civil Grand Jury or a designee appointed by the Civil Grand Jury.

## San Francisco BOARD OF SUPERVISORS

Exclusions: No employee or official of the City shall be appointed to the Committee. No vendor, contractor, or consultant of the City that performs work funded by bonds issued by the City shall be appointed to the committee.

Each member shall serve for a term of two years and for no more than two consecutive terms.

The Ordinance required the nine members meet certain minimum qualifications and be appointed as follows: three members by the Mayor, three members by the Board of Supervisors, two members by the City Controller, and one member by the Civil Grand Jury. Each member shall serve for a term of two years and may be reappointed for a second two-year term.

<u>Report:</u> The Committee shall issue regular reports on the results of its activities. A report shall be issued at least once a year.

Sunset Date: None.
