1	[Supporting California State Assembly Bill No. 1594 (Ting, Gipson, and Ward) - Firearms: Civil Suit]
2	
3	Resolution supporting California State Assembly Bill No. 1594, introduced by
4	Assembly Members Phil Ting, Mike Gipson, and Christopher Ward on January 3,
5	2022, that would specify that a gun industry member has created or maintained a
6	public nuisance if their failure to follow federal, state, or local law caused injury or
7	death or if the gun industry member engaged in unfair business practices.
8	
9	WHEREAS, Almost forty thousand lives are lost to gun violence every year, for
10	an average of 100 people shot and killed in the United States every day; and
11	WHEREAS, Every day 316 people are shot in the United States; and
12	WHEREAS, Gun violence is the leading cause of death for children and teens in
13	the United States; and
14	WHEREAS, San Francisco is not immune to the national gun violence epidemic,
15	as our communities have seen a dramatic increase in gun violence within the past year;
16	and
17	WHEREAS, Black Americans are disproportionately impacted by gun violence,
18	experiencing 10 times the gun homicides, 18 times the gun assault injuries, and nearly
19	3 times the fatal police shootings of white Americans; and
20	WHEREAS, Almost every industry in the United States can be held liable for the
21	harm their products cause, and the gun industry is not held to the same standard; and
22	WHEREAS, The Protection of Lawful Commerce in Arms Act (PLCAA) shields
23	gun producers and dealers from civil liability when their products are used to commit
24	crimes, when those companies break state law; and

1	WHEREAS, Existing law defines a public nuisance and provides that a public
2	nuisance may be remedied by an indictment or information, a civil action, or abatement;

4	WHEREAS, Assembly Bill No. 1594 empowers local and state governments and
5	Californians to sue those responsible for the manufacturing, sale, distribution and
6	marketing that contribute to conditions that endanger the health or safety of others or
7	engaging in unfair business practices; and
8	WHEREAS, The threat of civil litigation aims to compel the gun industry to take
9	every step possible to prevent illegal sales and theft to reduce gun violence; and
10	WHEREAS, The bill is co-sponsored by the California Attorney General and the
11	Brady Campaign; now, therefore, be it
12	RESOLVED, That the San Francisco Board of Supervisors supports Assembly
13	Bill No. 1594; and, be it
14	FURTHER RESOLVED, That the San Francisco Board of Supervisors hereby
15	directs the Clerk of the Board of Supervisors to transmit a copy of this Resolution to San
16	Francisco's State Legislative Delegation and to the City Lobbyist.

An act to add Part 2.5 (commencing with Section 3450) to Division 4 of the Civil Code, relating to firearms.

LEGISLATIVE COUNSEL'S DIGEST

AB 1594, as introduced, Ting. Firearms: civil suits.

Existing law defines a public nuisance and provides that a public nuisance may be remedied by an indictment or information, a civil action, or abatement. Existing law also regulates the manufacture, sale, and marketing of firearms.

This bill would specify that a gun industry member has created or maintained a public nuisance, as defined, if their failure to follow federal, state, or local law caused injury or death or if the gun industry member engaged in unfair business practices.

Vote: majority. Appropriation: no. Fiscal committee: no. State-mandated local program: no.

The people of the State of California do enact as follows:

1 SECTION 1. Part 2.5 (commencing with Section 3450) is 2 added to Division 4 of the Civil Code, to read:

AB 1594 —2—

PART 2.5. CIVIL SUITS RELATING TO FIREARMS 3450. A gun industry member shall have created or maintained a public nuisance, as defined in Section 3480, if their failure to follow federal, state, or local law caused injury or death or if the gun industry member engaged in unfair business practices.
