3 **Ordinance authorizing settlement of the lawsuit filed by Dacari Spiers against the City**
4 **and County of San Francisco for \$700,000; the lawsuit was filed on March 6, 2020, in**
5 **United States District Court, Northern District of California, Case No. 20-cv-01357-JSC;**
6 **entitled Dacari Spiers v. City and County of San Francisco, et al.; the lawsuit involves**
7 **an alleged civil rights violation.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Dacari Spiers v. City and County of
12 San Francisco, et al., United States District Court, Northern District of California, Case
13 No. 20-cv-01357-JSC by the payment of \$700,000. The lawsuit involves an alleged civil rights
14 violation occurring on October 6, 2019.

15 Section 2. The above-named action was filed in United States District Court, Northern
16 District of California on March 6, 2020, and the following parties were named in the lawsuit:
17 Plaintiff Dacari Spiers; Defendants City and County of San Francisco, Terrance Stangel,
18 Cuauhtemoc Martinez, Joshua Cabillo, Gonee Sepulveda, Bryan Neuerburg, Maria Ciriaco,
