THIS AMENDMENT (this "Amendment") is made as of September 15, 2021, in San Francisco, California, by and between **Intervision Systems, LLC.** ("Contractor"), and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Director of the Office of Contract Administration.

#### Recitals

WHEREAS, City and Contractor have entered into the Agreement (as defined below); and

WHEREAS, City and Contractor desire to modify the Agreement on the terms and conditions set forth herein to extend the contract duration; and

WHEREAS, the Agreement was competitively procured as required by San Francisco Administrative Code Chapter 21.1 through Request for Proposals #99400 "Tiers 1 and 2 of the Technology Marketplace 2.0" a Request for Proposal ("RFP") issued on June 20, 2018 and this modification is consistent therewith; and

WHEREAS, approval for this Agreement was obtained when the Civil Service Commission approved Contract number 44114-17/18 on July 10, 2018;

WHEREAS, the City's Board of Supervisors approved the Agreement by Resolution No. 010-19 on January 15, 2019;

WHEREAS, the City's Board of Supervisors approved the First Amendment by Resolution No. 442-20 on September 29, 2020 modifying the Agreement to increase the not-to-exceed amount from \$20,000,000 to \$31,000,000;

NOW, THEREFORE, Contractor and the City agree as follows:

## Article 1 Definitions

The following definitions shall apply to this Amendment:

1.1Agreement. The term "Agreement" shall mean the Agreement datedJanuary 1, 2019 between Contractor and City, as amended by the First Amendment datedOctober 19, 2020.

1.2 **Other Terms.** Terms used and not defined in this Amendment shall have the meanings assigned to such terms in the Agreement.

## Article 2 Modifications to the Agreement.

The Agreement is hereby modified as follows:

2.1 **Term of the Agreement.** Section 2.1 of the Agreement currently reads as follows:

2.1 **Term of the Agreement**. The term of this Agreement shall commence on the later of: (i) January 1, 2019; or (ii) the Effective Date and expire on December 31, 2021, unless earlier terminated as otherwise provided herein.

Such section is hereby amended in its entirety to read as follows:

2.1 **Term of the Agreement**. The term of this Agreement shall commence on the later of: (i) January 1, 2019; or (ii) the Effective Date and expire on December 31, 2023, unless earlier terminated as otherwise provided herein.

## Article 3 Effective Date

Each of the modifications set forth in Section 2 shall be effective on and after the date of this Amendment.

## Article 4 Legal Effect

Except as expressly modified by this Amendment, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect.
