

1 [Increasing Contract with Xtech to \$41,000,000]

2 **Resolution authorizing the Office of Contract Administration to enter into the First**
3 **Amendment between the City and Xtech (part of the Technology Store procurement vehicle),**
4 **in which the amendment shall increase the contract amount from \$24 million to \$41 million**
5 **and update certain standard contractual clauses.**

7 WHEREAS, the Office of Contract Administration, by competitive bidding, developed the
8 Technology Store procurement method for the purchase of products and services related to
9 Information Technology; and

10 WHEREAS, Xtech is one of the three products vendors who are part of the Technology
11 Store; and,

12 WHEREAS, the original contract with Xtech is dated January 1, 2009; has a term of three
13 years, through December 31, 2011, with possible extensions through December 31, 2013, and has a
14 contract amount of \$24 million; and

15 WHEREAS, the Board of Supervisors approved the original contract on December 9, 2008
16 by Resolution #508-08.

17 WHEREAS, the Office of Contract Administration estimates that the money projected to be
18 spent with Xtech could reach the contract's contract amount in the reasonably near future; and

19 WHEREAS, Charter section 9.118, "Contract and Lease Limitations," subsection (b),
20 requires Board of Supervisors approval of any contract estimated to exceed \$10 million in
21 expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be it

22 **RESOLVED**, that the Board of Supervisors authorizes the Office of Contract
23 Administration to enter into the First amendment to the contract with Xtech to update the standard
24 contractual clauses; and be it
