5	manage and staff the Curbside Management Program between FSP PPM Management,

10	WHEREAS, The Airport Commission authorized the issuance of a Request for
11	Proposals and to enter into final negotiations with the highest ranked proposer to Manage and
12	Staff the Airport's Curbside Management Program; and
13	WHEREAS, A three-member selection panel reviewed the two qualifying proposals and
14	conducted interviews with key staff of the proposed teams in accordance with the Commission
15	approved selection criteria; and,
16	WHEREAS, FSP PPM Management, LLC was determined to be the highest ranked
17	proposer; and,
18	WHEREAS, Staff negotiated the business terms of the Professional Services
19	Agreement (PSA) with FSP PPM Management, LLC, including scope, staffing, billing rates,
20	and management fee; and,
21	WHEREAS, On July 6, 2010, pursuant to Resolution 10-0228, the Airport Commission
22	awarded the PSA to FSP PPM Management, LLC for a 30-month initial term with three (3)
23	additional one-year renewal options to be exercised at the discretion of the Airport
24	Commission, at an initial not-to-exceed amount of \$10,450,000; and

1	WHEREAS, The Airport anticipates the contract duration to be up to five and one-half
2	(5 ½) years, in a total amount not-to-exceed \$26,000,000; and
3	WHEREAS, The Board of Supervisors through the approval of this resolution also
4	approves the contract modifications for the designated option years if the total overall not-to-
5	exceed amount of \$26,000,000 is not exceeded; and
6	WHEREAS, San Francisco Charter Section 9.118(b) provides that the agreements
7	entered into by a department, board or commission requiring anticipated expenditures by the
8	City and County of ten million dollars, shall be subject to approval by the Board of Supervisors
9	by resolution; and
10	WHEREAS, The Agreement is on file with the Clerk of the Board of Supervisors in File
11	No, which is hereby declared to be a part of this resolution as if set forth fully
12	herein, therefore, be it
13	RESOLVED, That the Board of Supervisors hereby approves the Professional Services
14	Agreement for Airport Contract 8994 – to Manage and Staff the Curbside Management
