San Francisco has an infrastructure to the support the expansion of this gunshot location technology. This is Phase III of the system, which will expand the current gunshot location system and integrate the community crime camera project into the areas where gunfire related crime is most prevelant.

The centerpiece of San Francisco's community policing strategy is engagement. This occurs primarily at the local level where commanders of district police stations regularly convene community meetings. At these community meetings citizens are given an oppportunity to present concerns to police management and receive updates on crime trends and crime-fighting strategies. If San Francisco is awarded this grant it will enhance our ability to provide our citizens with real-time information related to fire arm violence as captured from the gunshot locations system and other violent crimes that may be captured by the community crime cameras.

## (b) Related governmental and community initiatives that complement your agency's proposed use of COPS funding.

On June 19, 2010 the San Francisco Police Department established the Bay Area Regional Information Crime Center (BRICC). The mission of the BRICC is to act as a real time crime center, supporting operations to law enforcement agencies operating in the San Francisco Bay Area. The Bay Area is comprised of 9 of the 58 counties in California. The BRICC will provide effective criminal justice information exchange, leveraging technology and effective partnerships, to support personnel tasked with keeping our communities safe. An example of the leverage technology is the implementation of COMPSTAT in San Francisco. The data that ShotSpotter captures as a result of gunfire activity will be integrated in COMPSTAT fuel efforts of personnel and resource deployment. An example of the effective partnership is the sharing of lessons learned from the deployment of ShotSpotter with our law enforcement partners in the Bay Area cities of Richmond, East Palo, Belmont and Oakland. These are other cities in the Bay Area that have implemented ShotSpotter.

This project will enhance our involvement and commitment to community policing by enabling us to anticipate and respond to crime trends more rapidly. The enhancement of the gunshot location system and further expansion of community crime cameras provides for more crime data and the collection of additional evidence of criminal activity, which ultimately suppresses crime. The data from these systems not only supports a more efficient law enforcement operation but allows for additional engagement, and supports crime educational initiatives, informing the community of when and where crime is happening, and steps to be taken to avoid becoming victims of crime.

The Mayor of the City and County of San Francisco recently presented a FY 2010/11 balanced budget that addresses a \$483 million shortfall, which is further compounded by a budget shortall of \$575 million for FY 2009/10. To date, the San Francisco Police Department has allocated all available discretionary funds to the maintenance of basic personnel and infrastructure, including maintenance of current information technologies. Present fiscal constraints preclude us from expanding the system, though it has proven to be an effective and essential tool for combating gun violence.

In January 2008 the City and County of San Francisco embarked on an effort to deploy a gunshot location system manufactured by ShotSpotter, Inc. By December 2008, Phase I of the deployment of this system was completed. The system was operational and covered 3.3 square miles of the City. Phase II of this effort was completed using local funds. In fiscal year 2009/2010 the COPS Office awarded San Francisco \$1,000,000 to further expand the system. An additional 4 square miles of coverage will be installed and operational as a result of those funds. Phase II of this project is ahead of schedule and is expected to be complete by December 2010, bringing the total square miles of coverage to 7.3.

San Francisco is the second densest city in the nation with a total of 49 square miles with a population of approximately 800,000 with an additional 400,000 to 500,000 daily visitors. Historically, the most concentrated gunfire activity, both random and malicious, has fallen within a 20 square miles zone. The goal is to make operational a gunfire location system that will cover this zone that has been plagued with gunfire activity.

In 2005 San Francisco embarked on an effort to deploy surveillance cameras in areas of the city that were most prone to violent crime. The deployment of cameras was done is a piece-meal manner. The areas of deployment were prioritized by need and funding availability. By 2008 there were a total of 76 cameras in 26 locations. Since then there have been no additional cameras deployed, primarily due to budgetary constraints.

With the funding opportunity presented through COPS for Fiscal Year 2010-2011, San Francisco hopes to implement Phase III of the gunshot location system by adding 2 additional square miles to the coverage area. This will bring San Francisco to approximately 50% completion of our desired coverage area of 20 square miles, with 9.3. Additionally, with this funding we anticipate adding 30 surveillance cameras to the existing system. The cameras will be deployed in the areas most plagued by gunfire and other violent crimes, most notably homicides and robberies.

Phase III of this project will further enhance public safety by covering additional areas within San Francisco that have, historically, been plagued with gunfire activity. Additionally, this expansion will allow for the deployment of additional community safety cameras.

### A. Problem Identification

Anecdotal evidence from the media and interviews with local officials, police, and community members suggests that random gunfire is considered a serious problem in many large cities in the United States. Random gunfire has been defined as "the indiscriminate discharge of firearms into the air," which generally occurs during holiday celebrations, during weekends or sporting events, and often in association with the consumption of alcoholic beverages.

Random gunfire problems are distinguishable from other types of shooting incidents such as urban sniper attacks, gang shootouts, domestic homicides, and revenge shootings because (1) random gunfire is strictly an outdoor activity; (2) it is not usually part of other criminal activity such as drug dealing, assaults, or robberies; (3) generally, random gunfire shooters do not fire their weapons to intentionally injure or kill people.

Residents in communities with high levels of random gunfire live in perpetual fear; and law-abiding business owners and residents freely express their willingness to abandon or relocate from a neighborhood with random gunfire problems.

San Francisco is impacted by random and intentional gunfire problems as is the rest of the country. It is generally understood within the law enforcement community that acts of random gunfire create environments that are more conducive to acts of intentional gun violence. In 2008 San Francisco installed a gunshot location system manufactured by ShotSpotter, Inc., Mountain View, California. Since becoming operational the system has been a very useful tool for the San Francisco Police Department (SFPD). In the neighborhoods most impacted by violence crime, the system has alerted to gunfire incidents at a rate of close to 700% greater that is being reported by citizens. This system assists the SFPD by alerting its officers to a greater number of criminal incidents involving firearms. In 2009 The Center for Information Technology Research in the Interest of Society (CITRIS) reported on the efficacy of San Francisco's crime reduction camera program. Two significant findings were (1) there was a 23% reduction in property crimes associated with the placement of the cameras and (2) violent crime was displaced as a result of the placement of the cameras.

The use of the gunfire location system and community crime cameras has been a fundamental part of San Francisco's violence reduction strategy. We believe that the strategy is working. Accordingly, we believe that expansion of our technological capacities will further reduce the problem of gun violence in our city.

### **B.** Project Goals/Objectives

The goal of this project is to decrease the number of homicides and incidents of firearm related injuries in San Francisco. An objective is also to create a national model established in the use of technology in combating violent crime. Although, the technologies behind the gunshot location system is proven and sound, it has not been readily received in law enforcement and municipalities across the country. As San Francisco endeavors to more broadly use the gunshot location technology and integrate it with community crime cameras it provides a model of proven practice that influences crime fighting strategies nationally.

### D. Implementation Plan

San Francisco has an infrastructure to support the expansion of the gunshot location technology and the installation of additional community crime cameras. The project will be implemented in two stages, each adding one square mile of coverage. We are planning to have the first square mile operational within four months of receiving funding and the second within three months from the time that the first is completed. Effectively, the projected timeline for completing the first square mile of coverage is by the first quarter of 2011 with the second and final area of coverage for phase III of this project to be completed by the beginning of the third quarter of 2011. From the inception of this project the San Francisco Police Department has been the lead agency, amongst several San Francisco agencies, and will maintain as the primary project management. Accordingly, this continuation will ensure an effective and efficient implementation of phase III of this project.

The system will be tested after each square mile of deployment. After each square mile of deployment is completed the system will undergo collaboration and testing. The collaboration and testing consists of having law enforcement personnel go into the deployed area and under controlled conditions conduct live gunfire testing. This will ensure that the system properly detects and provides for accurate information regarding time and location of gunfire incidents. Once the data is evaluated the engineers with ShotSpotter can make any necessary adjustments of the equipment and software to address any performance concerns. The time line for testing is dependent on the successful deployment of the system. The projected period of time for testing is by the first quarter of 2011 and by the beginning of the third quarter of 2011.

### E. Evaluation Plan/Effectiveness of Program

The intended evaluation plan is to measure the number of incidents in a covered area and compare the results to a base-line once the expanded areas are operational. The evaluation benchmarks will be after six and twelve months of operation. The project has a project manager who is responsible for interfacing with line staff personnel, the end users. In addition, with phase III there will be a formal survey of line and supervisory personnel to determine the efficacy of the ShotSpotter system and the deployment of community crime cameras.

San Francisco has an infrastructure to the support the expansion of this gunshot location technology. This is Phase III of the system, which will expand the current gunshot location system and integrate the community crime camera project into the areas where gunfire related crime is most prevelant.

The centerpiece of San Francisco's community policing strategy is engagement. This occurs primarily at the local level where commanders of district police stations regularly convene community meetings. At these community meetings citizens are given an oppportunity to present concerns to police management and receive updates on crime trends and crime-fighting strategies. If San Francisco is awarded this grant it will enhance our ability to provide our citizens with real-time information related to fire arm violence as captured from the gunshot locations system and other violent crimes that may be captured by the community crime cameras.

# (b) Related governmental and community initiatives that complement your agency's proposed use of COPS funding.

On June 19, 2010 the San Francisco Police Department established the Bay Area Regional Information Crime Center (BRICC). The mission of the BRICC is to act as a real time crime center, supporting operations to law enforcement agencies operating in the San Francisco Bay Area. The Bay Area is comprised of 9 of the 58 counties in California. The BRICC will provide effective criminal justice information exchange, leveraging technology and effective partnerships, to support personnel tasked with keeping our communities safe. An example of the leverage technology is the implementation of COMPSTAT in San Francisco. The data that ShotSpotter captures as a result of gunfire activity will be integrated in COMPSTAT fuel efforts of personnel and resource deployment. An example of the effective partnership is the sharing of lessons learned from the deployment of ShotSpotter with our law enforcement partners in the Bay Area cities of Richmond, East Palo, Belmont and Oakland. These are other cities in the Bay Area that have implemented ShotSpotter.

This project will enhance our involvement and commitment to community policing by enabling us to anticipate and respond to crime trends more rapidly. The enhancement of the gunshot location system and further expansion of community crime cameras provides for more crime data and the collection of additional evidence of criminal activity, which ultimately suppresses crime. The data from these systems not only supports a more efficient law enforcement operation but allows for additional engagement, and supports crime educational initiatives, informing the community of when and where crime is happening, and steps to be taken to avoid becoming victims of crime.

The Mayor of the City and County of San Francisco recently presented a FY 2010/11 balanced budget that addresses a \$483 million shortfall, which is further compounded by a budget shortall of \$575 million for FY 2009/10. To date, the San Francisco Police Department has allocated all available discretionary funds to the maintenance of basic personnel and infrastructure, including maintenance of current information technologies. Present fiscal constraints preclude us from expanding the system, though it has proven to be an effective and essential tool for combating gun violence.

In January 2008 the City and County of San Francisco embarked on an effort to deploy a gunshot location system manufactured by ShotSpotter, Inc. By December 2008, Phase I of the deployment of this system was completed. The system was operational and covered 3.3 square miles of the City. Phase II of this effort was completed using local funds. In fiscal year 2009/2010 the COPS Office awarded San Francisco \$1,000,000 to further expand the system. An additional 4 square miles of coverage will be installed and operational as a result of those funds. Phase II of this project is ahead of schedule and is expected to be complete by December 2010, bringing the total square miles of coverage to 7.3.

San Francisco is the second densest city in the nation with a total of 49 square miles with a population of approximately 800,000 with an additional 400,000 to 500,000 daily visitors. Historically, the most concentrated gunfire activity, both random and malicious, has fallen within a 20 square miles zone. The goal is to make operational a gunfire location system that will cover this zone that has been plagued with gunfire activity.

In 2005 San Francisco embarked on an effort to deploy surveillance cameras in areas of the city that were most prone to violent crime. The deployment of cameras was done is a piece-meal manner. The areas of deployment were prioritized by need and funding availability. By 2008 there were a total of 76 cameras in 26 locations. Since then there have been no additional cameras deployed, primarily due to budgetary constraints.

With the funding opportunity presented through COPS for Fiscal Year 2010-2011, San Francisco hopes to implement Phase III of the gunshot location system by adding 2 additional square miles to the coverage area. This will bring San Francisco to approximately 50% completion of our desired coverage area of 20 square miles, with 9.3. Additionally, with this funding we anticipate adding 30 surveillance cameras to the existing system. The cameras will be deployed in the areas most plagued by gunfire and other violent crimes, most notably homicides and robberies. Phase III of this project will further enhance public safety by covering additional areas within San Francisco that have, historically, been plagued with gunfire activity. Additionally, this expansion will allow for the deployment of additional community safety cameras.

#### A. Problem Identification

Anecdotal evidence from the media and interviews with local officials, police, and community members suggests that random gunfire is considered a serious problem in many large cities in the United States. Random gunfire has been defined as "the indiscriminate discharge of firearms into the air," which generally occurs during holiday celebrations, during weekends or sporting events, and often in association with the consumption of alcoholic beverages.

Random gunfire problems are distinguishable from other types of shooting incidents such as urban sniper attacks, gang shootouts, domestic homicides, and revenge shootings because (1) random gunfire is strictly an outdoor activity; (2) it is not usually part of other criminal activity such as drug dealing, assaults, or robberies; (3) generally, random gunfire shooters do not fire their weapons to intentionally injure or kill people.

Residents in communities with high levels of random gunfire live in perpetual fear; and law-abiding business owners and residents freely express their willingness to abandon or relocate from a neighborhood with random gunfire problems.

San Francisco is impacted by random and intentional gunfire problems as is the rest of the country. It is generally understood within the law enforcement community that acts of random gunfire create environments that are more conducive to acts of intentional gun violence. In 2008 San Francisco installed a gunshot location system manufactured by ShotSpotter, Inc., Mountain View, California. Since becoming operational the system has been a very useful tool for the San Francisco Police Department (SFPD). In the neighborhoods most impacted by violence crime, the system has alerted to gunfire incidents at a rate of close to 700% greater that is being reported by citizens. This system assists the SFPD by alerting its officers to a greater number of criminal incidents involving firearms. In 2009 The Center for Information Technology Research in the Interest of Society (CITRIS) reported on the efficacy of San Francisco's crime reduction camera program. Two significant findings were (1) there was a 23% reduction in property crimes associated with the placement of the cameras and (2) violent crime was displaced as a result of the placement of the cameras.

The use of the gunfire location system and community crime cameras has been a fundamental part of San Francisco's violence reduction strategy. We believe that the strategy is working. Accordingly, we believe that expansion of our technological capacities will further reduce the problem of gun violence in our city.

# **B. Project Goals/Objectives**

The goal of this project is to decrease the number of homicides and incidents of firearm related injuries in San Francisco. An objective is also to create a national model established in the use of technology in combating violent crime. Although, the technologies behind the gunshot location system is proven and sound, it has not been readily received in law enforcement and municipalities across the country. As San Francisco endeavors to more broadly use the gunshot location technology and integrate it with community crime cameras it provides a model of proven practice that influences crime fighting strategies nationally.

#### D. Implementation Plan

San Francisco has an infrastructure to support the expansion of the gunshot location technology and the installation of additional community crime cameras. The project will be implemented in two stages, each adding one square mile of coverage. We are planning to have the first square mile operational within four months of receiving funding and the second within three months from the time that the first is completed. Effectively, the projected timeline for completing the first square mile of coverage is by the first quarter of 2011 with the second and final area of coverage for phase III of this project to be completed by the beginning of the third quarter of 2011. From the inception of this project the San Francisco Police Department has been the lead agency, amongst several San Francisco agencies, and will maintain as the primary project management. Accordingly, this continuation will ensure an effective and efficient implementation of phase III of this project.

The system will be tested after each square mile of deployment. After each square mile of deployment is completed the system will undergo collaboration and testing. The collaboration and testing consists of having law enforcement personnel go into the deployed area and under controlled conditions conduct live gunfire testing. This will ensure that the system properly detects and provides for accurate information regarding time and location of gunfire incidents. Once the data is evaluated the engineers with ShotSpotter can make any necessary adjustments of the equipment and software to address any performance concerns. The time line for testing is dependent on the successful deployment of the system. The projected period of time for testing is by the first quarter of 2011 and by the beginning of the third quarter of 2011.

## E. Evaluation Plan/Effectiveness of Program

The intended evaluation plan is to measure the number of incidents in a covered area and compare the results to a base-line once the expanded areas are operational. The evaluation benchmarks will be after six and twelve months of operation. The project has a project manager who is responsible for interfacing with line staff personnel, the end users. In addition, with phase III there will be a formal survey of line and supervisory personnel to determine the efficacy of the ShotSpotter system and the deployment of community crime cameras.
