17	Be it ordained by the People of the City and County of San Francisco:

19	Section 1. Chapter 22A of the Administrative Code is hereby amended by revising
20	Sections 22A.3 and 22A.4, to read as follows:
21	SEC. 22A.3. COMMITTEE ON INFORMATION TECHNOLOGY.
22	Establishment and Composition. There is hereby created a Committee on
23	Information Technology (COIT).
24	(a) COIT shall be composed of seven eight permanent members consisting of the
25	Mayor, the President of the Board of Supervisors, the Controller, the City Administrator, the

Clerk of the Board of Supervisors, the Executive Director of the Human Rights Commission, and the Chief Information Officer (CIO), and the Chief Information Security Officer (CISO), or their designees. The Mayor, the President of the Board of Supervisors, the Controller, the City Administrator, the Clerk of the Board of Supervisors, the Executive Director of the Human Rights Commission, and the CIO, shall elect a Chair, who shall serve for a two-year term. All of the permanent members of COIT shall be eligible to serve as Chair. The City Administrator or the City Administrator's designee shall serve as Chair. Five additional Department Heads shall be recommended by the Chair and approved by the permanent members for two-year terms, one representing each of the major service areas: (a) Public Protection, (b) Human Welfare and Neighborhood Development, (c) Community Health, (d) Culture and Recreation, and (e) General Administration and Finance; and three additional non-permanent members representing the major service area of Public Works, Transportation, and Commerce. The seven eight permanent members and eight non-permanent members will shall be voting members of COIT.

SEC. 22A.4. CHIEF INFORMATION OFFICER.

- (a) **Establishment and Composition:** There is hereby created the position of Chief Information Officer (CIO) for the City and County of San Francisco. The CIO shall:
 - (1) Be appointed by the <u>City Administrator</u>, <u>with the concurrence of the Mayor</u>.
- (2) Serve as a permanent member of the Committee on Information

 Technology (COIT) with the authority and responsibility to develop recommendations and implement COIT standards, policies, and procedures for all City Departments.
- (3) Serve as the Director of the Department of Technology with responsibility for making recommendations regarding development, implementation, maintenance, operation, and support of all citywide ICT.

- (b) Purpose and Duties: The CIO shall (i) monitor trends and advances in ICT; (ii) advise the Mayor, Board of Supervisors, and City Departments regarding opportunities to provide higher quality, more timely, and more cost-effective governmental services; (iii) ensure coordinated and non-duplicative acquisition of ICT technologies for maximum cost effectiveness and use; (iv) ensure sharing of ICT technologies among City Departments as the most cost-effective method of providing the highest quality and most timely governmental services that could otherwise be cost prohibitive; (v) develop uniform policies and coordinated systems for the use, acquisition, and implementation of ICT technologies; and (vi) establish Citywide standards, and procedures to ensure cost-effective and useful retrieval and exchange of information both within and among the various City Departments and from the City to the people of San Francisco; and (vii) direct the City's cyber security program.
- (c) The CIO shall (i) consult with City Departments about ICT staffing needs and develop an ICT staffing plan for review and approval by COIT; and (ii) monitor hiring of ICT staff and adherence to the ICT staffing plan adopted by COIT.
- (d) The CIO shall develop for the review and approval of COIT policies and procedures for the effective management of technology investments throughout their entire life-cycle, including, but not limited to project definition, procurement, development, implementation, operation, performance evaluation, and enhancement or retirement.

Section 32. The Administrative Code is hereby amended by adding Chapter 22I, consisting of Sections 22I.1, 22I.2, 22I.3, 22I.4, 22I.5, and 22I.6, to read as follows:

CHAPTER 221: OFFICE OF CYBER SECURITY AND **DUTIES OF THE CHIEF INFORMATION SECURITY OFFICER**

SEC. 22I.1. FINDINGS.

1	
2	On June 4, 2021, Mayor London Breed issued Executive Directive No. 21-02, announcing that
3	protecting the City's technology and information is vital to the proper functioning of the City and the
4	ability of City departments and personnel to serve residents. In order to further the protection of City
5	assets, the prevention, detection, and remediation of cyber-related incidents is a top priority of the City
6	and essential to the security of San Francisco government and its residents. In the directive, the Mayor
7	directed the City's Chief Information Officer and the City Administrator to recommend changes to the
8	Administrative Code to formalize and strengthen the City's cyber security functions and programs.
9	SEC. 221.2. PURPOSE OF CHAPTER.
10	(a) The purpose of this Chapter 22I is to strengthen and coordinate the City's security of
11	information resources. The creation of the Office of Cyber Security will improve the City's information
12	security by doing the following:
13	(1) ensure coordination of City Departments' response to cyber security threats;
14	(2) identify primary responsibility for the City's response during emergencies caused by
15	cyber security attacks;
16	(3) share best information security practices, procedures, and requirements with City
17	<u>Departments;</u>
18	(4) provide review of proposed technology purchases by City Departments to address
19	cyber security risks during procurement; and
20	(5) avoid uncoordinated and duplicative information or system security purchases by
21	City Departments when such technology can be more effectively purchased as part of a coordinated
22	City effort for maximum cost effectiveness and use.
23	(b) In enacting and implementing this Chapter 22I, the City is assuming an undertaking only to
24	promote the general welfare. It is not assuming, nor is it imposing on its officers and employees, an

obligation for breach of which it is liable in money damages to any person who claims that such breach

proximately caused injury.

2	(c) Municipal Transportation Agency. Consistent with Charter Section 8A.101(d), the Municipal
3	Transportation Agency shall comply with the provisions of this Chapter 22I and shall be solely
4	responsible for its administration and enforcement with respect to matters within the Municipal
5	Transportation Agency's jurisdiction. The Municipal Transportation Agency Board of Directors shall
6	provide the City Administrator with an annual report of reported incidents and its compliance with the
7	established City information security standard.
8	(d) Public Utilities Commission. Consistent with Charter Section 8B.121(a), the Public Utilities
9	Commission shall comply with the provisions of this Chapter 22I and shall be solely responsible for its
10	administration and enforcement with respect to matters within the Public Utilities Commission's
11	jurisdiction. The Public Utilities Commission shall provide the City Administrator with an annual
12	report of reported incidents and its compliance with the established City information security standard.
13	SEC. 221.3. DEFINITIONS.
14	For purposes of this Chapter 22I, the following definitions shall apply:
15	"City" means the City and County of San Francisco and all of its units or components of
16	government.
17	"Chief Information Officer" means the Chief Information Officer for the City appointed
18	pursuant to Administrative Code Section 22A.4.
19	"City Department" means any unit or component of City government, including but not limited
20	to named departments, boards and commissions, offices, agencies, and officials.
21	"Committee on Information Technology" or "COIT" means the committee established in
22	Administrative Code Section 22A.3.
23	"Information and Communications Technology" or "ICT" means information and
24	communications technology and computer-based equipment and related services designed for the
25	storage, manipulation, and retrieval of data by electronic or mechanical means, or both.

2	"Information Resources" means Information and Communications Technology operated by or
3	for the City, including equipment, facilities, systems, applications, and cloud services that relate
4	directly to data processing equipment or services which are directly managed by various departmental
5	divisions for Management Information Systems (MIS), including but not limited to, the Controller's
6	Information Services Division (ISD), the Airport's MIS Division, the Public Utilities Commission's
7	Bureau of MIS, and the Department of Public Health's MIS.
8	"Information Security Standards" means standard requirements created by the Chief
9	Information Security Officer for the protection and resiliency of the City's information resources.
10	SEC. 221.4. OFFICE OF CYBER SECURITY.
11	(a) Establishment. The Office of Cyber Security is hereby created within the Department of
12	Technology and shall be headed by the Chief Information Security Officer and staffed by such officers
13	and employees as are authorized pursuant to the budgetary and fiscal provisions of the Charter.
14	(b) Mission and Purposes. The Office of Cyber Security shall have these missions and
15	purposes:
16	(1) Advising the Mayor, the Board of Supervisors, the City Administrator, the City
17	Chief Information Officer, and City Departments regarding information security for City Departments.
18	(2) Advising the Committee on Information Technology (COIT) on compliance with
19	adopted information security standards, policies, and funding plans, and serving as a permanent
20	member of COIT.
21	(3) Protecting City-connected technology and information resources.
22	(4) Continuously improving the City's ability to detect cyber security events, contain
23	and eradicate compromises to security, and restore information resources to a secure and operational
24	<u>status.</u>
25	(5) Evaluating technology vendors and partners to identify cyber security risks to City
	operations.

2	(7) Work with City Departments through the designated Departmental Information
3	Security Officers to reduce the City's risk to cyber security incidents.
4	(8) Develop and update citywide cyber security requirements to
5	mitigate the City's risk profile, and comply with legal and regulatory cyber security requirements.
6	(9) Support City Departments' implementation of the City's information security
7	<u>standards.</u>
8	(10) Provide the Mayor and City Administrator with an annual report of reported
9	incidents and each City Department's compliance with the established City information security
10	<u>standard.</u>
11	SEC.22I.6. CITY DEPARTMENTS.
12	(a) City Departments. Each City Department, ("Department") shall:
13	(1) Appoint a Departmental Information Security Officer (DISO) to coordinate cyber
14	security efforts with the CISO.
15	(2) Adopt the City's information security standard for reducing the risk of compromise
16	to the City's information resources as a basis of their Department's cyber security program.
17	(3) Consult with the Office of Cyber Security to evaluate cyber security risk prior to
18	initiating new information technology projects, implementing major changes to information systems, or
19	selecting vendors of technologies or vendors providing technology-related services.
20	(4) Support cyber incident response in accordance with the then-existing San Francisco
21	Unified Cyber Command Plan.
22	(5) Conduct and update a Department cyber security risk assessment based on
23	standards established by the Office of Cyber Security.
24	(6) Test and update the Department's cyber security emergency response plan based on
25	standards established by the Office of Cyber Security.

2	(7) Maintain Department cyber security requirements that are equivalent to or greater
3	than the citywide information security standards and provide non-standard Department requirements
4	to the Office of Information Security.
5	(8) Participate in citywide cyber security forum meetings organized by the Office of
6	<u>Cyber Security.</u>
7	(b) Given the broad definition of "City Department" under Section 221.3, and the wide range
8	of sizes of City Departments, the requirement in subsection (a), above, that each City Department
9	appoint a DISO shall not be understood to preclude the same person from serving as DISO for more
10	than one City Department, nor preclude the DISO for a City Department from having other
11	<u>responsibilities.</u>
12	
13	Section 3. Effective Date. This ordinance shall become effective 30 days after
14	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
15	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
16	of Supervisors overrides the Mayor's veto of the ordinance.
17	
18	Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
19	intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
20	numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
21	Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
22	additions, and Board amendment deletions in accordance with the "Note" that appears under
