3 **Resolution celebrating and recognizing the cultural contributions of Persian culture**
4 **and history to modern society on the occasion of the celebration of Nowruz, the**
5 **Persian New Year.**

7 WHEREAS, Nowruz marks the traditional Iranian New Year, which originated in ancient
8 Persia, and dates back more than 3,000 years; and

9 WHEREAS, Nowruz, meaning a “New Day,” occurs on the vernal equinox and
10 celebrates the arrival of spring; and

11 WHEREAS, Nowruz symbolizes a time of renewal and community, it harkens the
12 departure from the trials and tribulations of the previous year and brings hope for the New
13 Year; and

14 WHEREAS, Nowruz is celebrated by more than 90,000,000 people all over the world,
15 including in Iran, Afghanistan, China, United States of America, India, Tajikistan, Turkey and
16 beyond; and

17 WHEREAS, Nowruz is a nonreligious and universal celebration of the arrival of spring
18 celebrated by Iranian Americans of all backgrounds, including those with Baha'i, Christian,
19 Jewish, Muslim, Zoroastrian, and nonreligious backgrounds; and

20 WHEREAS, Nowruz serves to remind the United States of the many lasting
21 contributions of the Persian civilization to the world and the noteworthy impact of Iranian
22 Americans to the social and economic fabric of society in the United States; and

23 WHEREAS, Iranian Americans continue to make contributions in all sectors of
24 American public life, including as government, military, and law enforcement officials working

1 to uphold the Constitution of the United States and to protect all people in the United States;
2 and

3 WHEREAS, Nowruz embodies the tradition that each individual's thinking, speaking,
4 and conduct should always be virtuous, and the ideal of compassion for our fellow human
5 beings regardless of ethnicity or religion, and connects the Persian New Year to the values of
6 human rights; now, therefore, be it

7 RESOLVED, That the City and County of San Francisco celebrates and recognizes the
8 historical significance of Nowruz; and, be it

9 FURTHER RESOLVED, That the City and County of San Francisco expresses its
10 appreciation for the contributions of Iranian Americans to society in the San Francisco Bay
11 Area in observance of Nowruz; and, be it

12 FURTHER RESOLVED, That the City and County of San Francisco wishes Iranian
13 Americans and the people of Iran and all those who observe this holiday a prosperous new
14 year.
