Dear Supervisors:

I am a resident of District 11. and I urge you to vote for the Mayor's "Proclamation of Local Emergency – Drug Overdoses in the Tenderloin" (File No. 211320) this Thursday. The residents of the Tenderloin are living with crime, drug use, drug dealing, and dangerous conditions. Those unhoused in the Tenderloin also endure unsafe, unhealthy, and deteriorating conditions.

The Emergency Proclamation will enable the City to have a more effective emergency response, with public health, behavioral health, social, or housing services. The Proclamation requires the Controller's office to report to the Board on the City's use of funds to support the emergency response. The state of emergency will only last 90 days, and the Board retains the ability to terminate the state of emergency early.

In a recent poll of San Franciscans, over 80% of respondents said that homelessness and street behavior are the top issues facing the city, and 88% said that the situation is getting worse. We are looking to you, our Supervisors, to authorize faster and more effective action to address this crisis. Treat this disaster like the emergency it is. Approve the Mayor's Proclamation of a Local Emergency -- Drug Overdoses in the Tenderloin. Thank you!
