shall be only be permitted between the hours of 12:00 p.m. and 10:00 p.m. daily; now, therefore, be it

RESOLVED, That in accordance with California Business and Professions Code, Section 23958.4, the Board of Supervisors of the City and County of San Francisco hereby determines that transfer of a Type-48 on-sale general public premises liquor license to Pacific Cocktail Haven located at 550 Sutter Street (District 3), will serve the public convenience or necessity of the City and County of San Francisco; and, be it

FURTHER RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby endorses and adopts the recommendations of the Police Department listed above and recommends that the Department of Alcoholic Beverage Control issue the license with those conditions.
