

1 [Grant Agreement Amendment - Wu Yee Children's Services - Early Care and Education
2 Integrated Services - \$81,044,162]

3 **Resolution approving a third modification of the grant between the City and County of**
4 **San Francisco and Wu Yee Children's Services, for the provision of Early Care and**
5 **Education Integrated Services to support the City's implementation of the San**
6 **Francisco Citywide Plan For Early Care and Education to increase the grant amount by**
7 **\$5,234,074 resulting in a revised total grant amount of \$81,044,162 to commence**
8 **following Board approval, with no changes to the grant period of July 1, 2017, through**
9 **June 30, 2022.**

11 WHEREAS, The City and County of San Francisco, wishes to provide Early Care and
12 Education Integrated Services by delivering subsidy administration and resource and referral
13 services; and

14 WHEREAS, The Office of Early Care and Education, in partnership with the Human
15 Services Agency, conducted a Request for Proposals for these services in January 2017; and

16 WHEREAS, Wu Yee Children's Services submitted a responsive and responsible
17 proposal and was awarded the grant for the total amount of \$32,118,731 in July 1, 2017; and

18 WHEREAS, The Human Services Agency Commission approved this grant to Wu Yee
19 Children's Services at its meeting of April 27, 2017; and

20 WHEREAS, The Board of Supervisors Resolution No. 265-17 approved the grant with
21 Wu Yee Children's Services to provide Early Care and Education Integrated Services, for the
22 period of July 1, 2017, through June 30, 2020, in the not to exceed amount of \$32,118,731;
23 and

24 WHEREAS, The Office of Early Care and Education, in partnership with the Human
25 Services Agency, approved grant with Wu Yee Children's Services to provide Early Care and

1 Education Integrated Services, for the term of July 1, 2017, through June 30, 2022, in the total
2 not to exceed amount of \$32,118,731; and

3 WHEREAS, A first modification of the Wu Yee Children's Services grant in the amount
4 of \$7,440,303 resulting in a new not to exceed amount of \$39,559,034 was requested in April
5 2019; and

6 WHEREAS, The Human Services Commission approved the first modification to the
7 Wu Yee Children's Services grant at its meeting of May 22, 2019; and

8 WHEREAS, The Board of Supervisors Resolution No. 268-19 approved the grant with
9 Wu Yee Children's Services to provide Early Care and Education Integrated Services, for the
10 period of July 1, 2017, through June 30, 2020, in the not to exceed amount of \$39,559,034;
11 and

12 WHEREAS, A second modification of the Wu Yee Children's Services grant in the
13 amount of \$36,251,054 resulting in a new total amount of \$75,810,088 was requested in
14 November 21, 2019; and

15 WHEREAS, The Human Services Commission approved the second modification to
16 the Wu Yee Children's Services grant at its meeting of November 21, 2019; and

17 WHEREAS, The Board of Supervisors Resolution No. 046-20 approved the grant with
18 Wu Yee Children's Services to provide Early Care and Education Integrated Services, for the
19 period of July 1, 2017, through June 30, 2020, in the not to exceed amount of \$75,810,088;
20 and

21 WHEREAS, A third modification of the Wu Yee Children's Services grant in the
22 amount of \$5,234,074 resulting in a new total amount \$81,044,162 was requested in January
23 of 2022; and

24 WHEREAS, The Human Services Agency Commission approved this modification to
25 the Wu Yee Children's Services grant at its meeting of January 27, 2022; now, therefore be it

1 RESOLVED, That the Board of Supervisors hereby approves the third modification of
2 the grant with Wu Yee Children's Services in the amount of \$5,234,074 resulting in a revised
3 total amount of \$81,044,162 for the period of July 1, 2017, through June 30, 2022; and, be it

4 FURTHER RESOLVED, That within thirty (30) days of the modification being fully
5 executed by all parties, the Human Services Agency shall provide the final grant to the Clerk
6 of the Board for inclusion into the official file.
