2 2022: Independent Coroner's Offices]

3 **Resolution supporting California State Assembly Bill No. 1608, authored by Assembly**  
4 **Member Mike A. Gipson, The Angelo Quinto Act of 2022: Independent Coroner's**  
5 **Offices.**

7 WHEREAS, In December of 2020, Angelo Quinto was tragically killed by police; Angelo  
8 had been suffering from a mental health episode when his family called the police for help  
9 with de-escalating the situation; while Angelo was handcuffed, a responding officer knelt on  
10 Angelo's neck for at least four and a half minutes while another officer restrained his legs;  
11 Angelo lost and never regained consciousness -he died in a hospital three days later; and

12 WHEREAS, The Contra Costa County Coroner's Office ruled that Angelo's death was  
13 the result of "excited delirium;" this term is often attributed to sudden unexplained deaths of  
14 individuals while in police custody; and

15 WHEREAS, Angelo's death has garnered great attention and increased scrutiny on  
16 diagnoses used to shield and absolve officers from accountability; and

17 WHEREAS, According to a 2020 study by the Oregon Health & Science University  
18 School of Medicine, published cases of excited delirium rarely, if ever, happen independently  
19 of police involvement; and additionally, in July of 2021, the American Medical Association  
20 adopted a new policy opposing the "excited delirium" diagnosis; specifically, their position is  
21 that the "current evidence does not support 'excited delirium' as an official diagnosis," and  
22 other recognized organizations, like the National Institute of Health, note that much more  
23 research must be discovered in this area; and

1           WHEREAS, The blanket diagnosis has, in part, reinvigorated the need for greater  
2 transparency in the investigation medical examination process, and it has also led to a goal of  
3 eliminating potential conflicts of interest in law enforcement; and

4           WHEREAS, This perception of bias should be remedied by ensuring that all local death  
5 investigations are conducted independently and objectively by an independent Medical  
6 Examiner or Coroner's Office that is separate from the Sheriff's Office; and

7           WHEREAS, All 58 counties in California have a sheriff's department, but only ten  
8 counties have a separate coroner or medical examiner's office; and

9           WHEREAS, Currently, state law does not require a sheriff to have any medical  
10 background or certification to assume the duties of a coroner, and California is only one of  
11 three states that allows counties to combine the offices of the coroner and sheriff, which  
12 increases the potential for conflicts of interest in law enforcement handling the duties of the  
13 coroner; and

14           WHEREAS, San Francisco has already separated the duties of the coroner from the  
15 sheriff, as have Los Angeles and San Diego; these coroners are independent medical  
16 examiners who are required to be licensed physicians and surgeons duly qualified as  
17 specialists in pathology; and

18           WHEREAS, Section 24304.1. of the Government Code permits County Boards of  
19 Supervisors to consolidate the duties of certain county offices, including, but not limited to the  
20 sheriff and the coroner; and

21           WHEREAS, Currently, state law does not require a sheriff to have any medical  
22 background or certification to assume the duties of a coroner, in contrast to independent  
23 medical examiners who are required to be licensed physicians and surgeons duly qualified as  
24 specialists in pathology; and

1           WHEREAS, A consistent statewide policy towards independent coroner's offices would  
2 help to ensure that medical examinations and investigations of sudden, violent, or  
3 unexplained/suspicious deaths are conducted objectively; and

4           WHEREAS, California State Assembly Bill No. 1608 would separate the duties of the  
5 coroner from the duties of the sheriff, strengthening the medical examination process, thereby  
6 eliminating perceived and actual conflicts of interest and increasing accountability and  
7 transparency when determining the cause of death; now, therefore, be it

8           RESOLVED, That the Board of Supervisors expresses its support for California State  
9 Assembly Bill 1608 (Gipson), and respectfully requests the California Legislature pass and  
10 Governor Gavin Newsom sign California State Assembly Bill No. 1608 into law; and, be it

11          FURTHER RESOLVED, That copies of this Resolution will be sent to the Office of  
12 Assembly Member Mike A. Gipson, along with a copy of the support letter referenced below;

14          FURTHER RESOLVED, That the Clerk of the Board of Supervisors shall submit a copy

An act to amend Sections 24300, 24304, and 24304.1 of the Government Code, relating to local government.

LEGISLATIVE COUNSEL’S DIGEST

AB 1608, as introduced, Gipson. County officers: consolidation of offices.

Existing law authorizes the board of supervisors of a county to consolidate the duties of various county offices in various combinations, including combining the duties of the sheriff and the coroner.

This bill would delete the authority to combine the duties of the sheriff with the duties of the coroner.

Vote: majority. Appropriation: no. Fiscal committee: no.  
State-mandated local program: no.

Dear Assembly Member Gipson,

The California State Association of Counties (CSAC) respectfully writes in opposition of your measure, Assembly Bill 1608, which would create unavoidable, significant costs to counties, while removing the existing authority of our 58 elected county boards of supervisors.


As introduced, AB 1608 strikes the authority of all county boards of supervisors to combine the duties of the county office of the Sheriff and coroner by way of ordinance. Currently, 48 of the 58 counties in our state consolidate the duties of the county-elected Sheriff and the coroner into a single office. The remaining counties have established an independent Office of the Medical Examiner or a coroner's office that is separate from the Sheriff's. Although AB 1608 does not require counties to create an independent Office of the Medical Examiner, many counties may be forced to do so given the high volume of cases they receive. If this takes place, projected costs to create and sustain operations of a medical examiner's office would likely exceed \$1 million annually. Another option could be for a county to contract with neighboring counties and independent forensic pathologists, but as noted, it will not make sense for most medium and large sized counties with large caseloads. As currently drafted, a county is also permitted to consolidate the functions and duties of the coroner with other county offices, such as the public administrator. However, not only is it unclear how the administrative, medical, and investigative functions of the coroner could be consolidated with other offices, more notably it would require widespread changes with regards to staffing, resources, security, and physical space.

While prohibiting the consolidation of the Sheriff and coroner would be a substantial undertaking, impacting the budget of most counties across California, it would strip county boards of supervisors of their fundamental duty to make sound fiscal decisions on behalf of their constituents. Additionally, supervisors can exercise their existing authority to combine the duties of the coroner with other county offices if that is the will of the voters.

Ultimately, CSAC genuinely appreciates the intent of this legislation and is deeply sensitive to the concerns from the community. Thus, while we regretfully oppose AB 1608 as introduced, we look forward to continuing conversations.
