14 which includes restricting private vehicles on certain slow street segments in Golden Gate
15 Park including on John F. Kennedy Drive, making certain street segments one-way,
16 establishing bicycle lanes, and urging additional changes to improve public access to Golden
17 Gate Park; making associated findings under the California Vehicle Code; affirming the
18 Planning Department’s determination under the California Environmental Quality Act; and
19 making findings of consistency with the General Plan, and the eight priority policies of
20 Planning Code, Section 101.1; and

21 WHEREAS, That proposed Ordinance (File No. 220261) is currently pending
22 committee action by the Land Use and Transportation Committee of the San Francisco Board
23 of Supervisors; and

1 WHEREAS, On April 5, 2022, Supervisor Connie Chan introduced a same subject
2 Ordinance amending the Park Code to adopt the Golden Gate Park Access and Safety Plan
3 with modified configurations; and

4 WHEREAS, That proposed Ordinance (File No. 220339) is currently pending
5 committee action by the Land Use and Transportation Committee of the San Francisco Board
6 of Supervisors; and
